- full OA can be issued from one to five years, in multiples of one year periods. Should you choose to renew your OA for more than one year, the fee is calculated by multiplying the annual fee by the number of years chosen
  - where indicated, the number of vehicles refers to the maximum number of vehicles used at any one time in each year to provide that service category.
