Hi David, Paul,

Good to meet with you yesterday. I hope we conveyed to you that Solar Citizens, whilst born out of protecting the legacy feed-in tariffs that helped kick-start rooftop solar in Australia, we're now more broadly focussed on a fair go for solar across a range of issues and are looking to support policies that help enable solar to grow as part of the inevitable energy transition.

To that end we'll continue to take a particular interest not only in the range of positive election policies the Palaszczuk Govt has committed to (Solar auction, 50% by 2030, 1M Solar Rooftops, Fair FiT) but also any changes to tariff pricing structures that have the potential to negate any benefits to solar from a "fair" FiT by leading to higher fixed costs.

As promised I've provided some information below about the proposed rule change currently with the AEMC concerning Local Network Credits for distributed generation. This is an exciting field and if successful would help the business cases for community and commercial solar. As a leading advocate of solar power, it would be great to see the QLD Government take an interest in this area with a submission to the AEMC rule change and look into ways to support its implementation.

Local Network Credits - Helping to share the benefits of Solar more broadly

- Research into the network benefits of distributed energy such as solar rooftops is limited in Australia. However, in many instances rooftop PV helps ease network constraints and thereby potential costs by distributing electricity over a shorter distance from generation to consumption. These benefits are not currently reflected in electricity pricing.
- The concept of Local network credits are reduced network tariffs for electricity generation used within a defined local network area.
- This recognises that the generator is using only part of the electricity network and reduces the network charge accordingly.
- The rationale for a local network charge is to address inequitable network charges levied on a generator/consumer pair; disincentivise duplication of infrastructure (private wires) set up to avoid network charges altogether; and maintain use of the electricity network
- The City of Sydney, Total Environment Centre, and the Property Council of Australia have submitted a rule change to the AEMC.
- The rule change request is for distribution network service providers to calculate the long-term economic benefits that embedded generators provide to distribution and transmission networks, and pay embedded generators a local generation network credit that reflects those estimated long-term benefits.

- The AEMC has published a consultation paper to facilitate public discussion on the issues raised by the rule change request. Submissions on the rule change request are due by 4 February 2016.

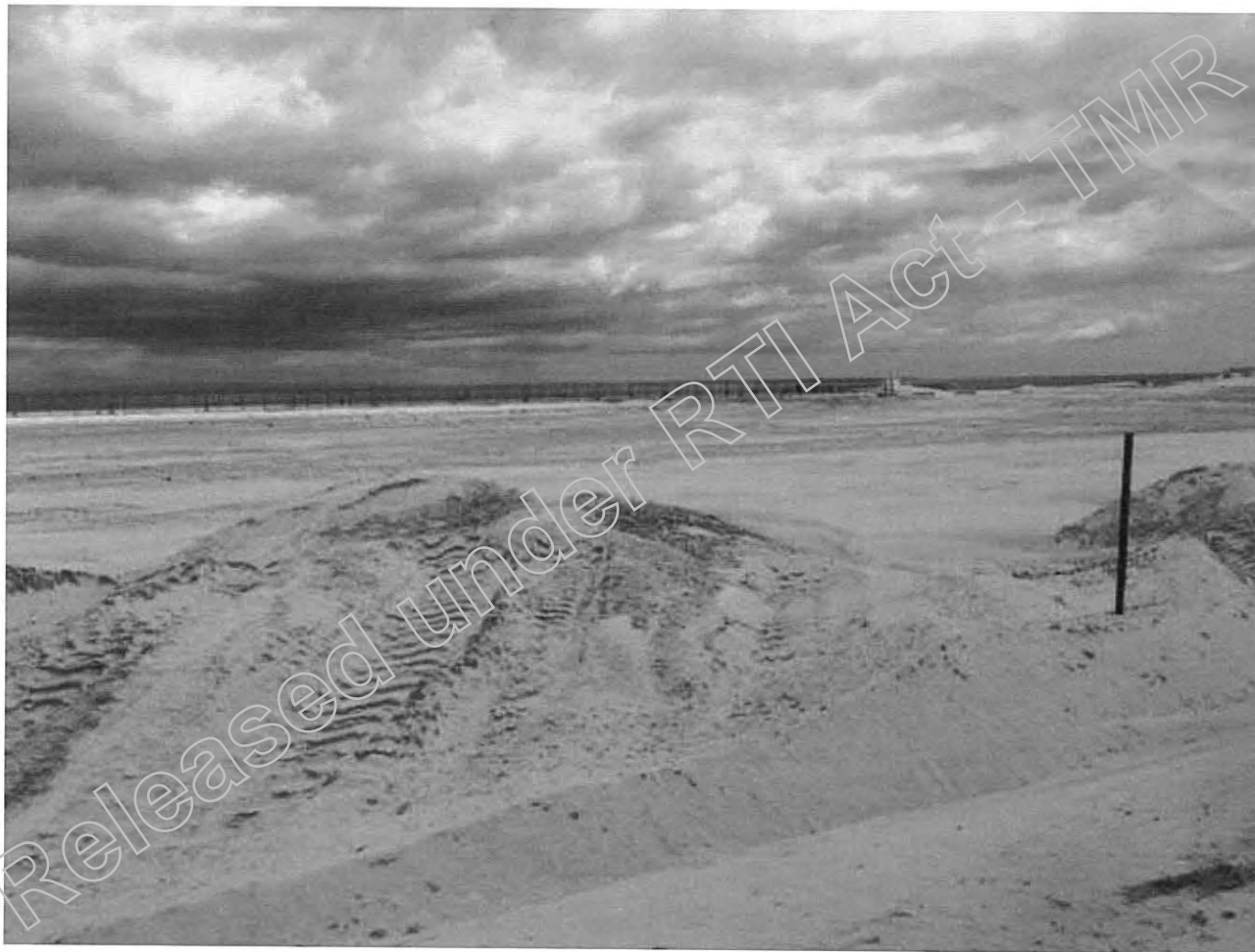

Hi Mark – hope that you are travelling well.

I am currently in Canberra talking national radioactive waste for two days in my capacity as a member of the Dept of Industry's Independent Advisory Panel and wanted to advise re a set of conversations that happened today.

When the b'crats were discussing respective sites I asked re their response to the Qld Govts clear rejection of the federal plan: they said that they while they were aware of letters sent to concerned people near the proposed site these were signed by a staffer not the Minister, that the Feds have not received any letter from the Qld Govt formally calling for the withdrawal of the site and that in discussions between Minister Frydenberg and Premier Palaszczuk / Minister Lynham these two conveyed that while the Qld Govt was opposed they saw this as a Commonwealth matter.

I raised the issue of the state plebiscite and they responded that there was no pre-determined timeline or terms of reference and 'plenty of flexibility' for the state government re this.

In short they seem to be thinking that Qld Labor will blink – and I think the no facility message needs to be clearly re-sent to the Feds.

On a separate matter I also saw Greens Senator and national nuclear spokes Scott Ludlam – he will be in Brisbane for a Senate Inquiry on Thursday 10 March. I asked if he knew you – he doesn't but would be keen to meet re this issue. He would be available for an early breakfast meeting if that worked for you - if this sounds ok let's know and I will do a more procedurally proper introduction.....

I refer to your email dated 11 February 2016 addressed to the Honourable Dr Anthony Lynham MP, Minister for State Development and Minister for Natural Resources and Mines concerning the Federal Government's consideration of potential sites for a National Radioactive Waste Storage Facility. The Minister has asked me to respond on his behalf.

The Queensland Government is not supportive of the establishment of a radioactive waste storage facility anywhere in Queensland. The Queensland Government has written to the Federal Government outlining its position, but also acknowledges the proposed facility is a Federal Government decision with local landholders.

Any matter concerning uranium waste storage in Queensland is regulated under the *Radiation Safety Act 1999*. As this Act falls within the portfolio responsibilities of my ministerial colleague, the Honourable Cameron Dick MP, Minister for Health and Minister for Ambulance Services, I have forwarded a copy of your correspondence to his office for consideration.

Queensland Law Society president Bill Potts says a report highlighting design flaws in the National Disability Insurance Scheme should serve as a warning to Queensland as it decides on a model to implement the National Injury Insurance Scheme.

“The NIIS is a safety net for some of society’s most vulnerable people, those catastrophically injured in car accidents,” Mr Potts said.

“It will fail these people if it is implemented in a way that cannot be sustainably funded or if it strips them of the dignity and their right of choice.”

Details of defects in the NDIS were revealed in a report in The Australian Newspaper on Friday.

Mr Potts said that one of the options being considered by the government is a NIIS which takes away the common law rights of victims and forces them into the scheme dictating their care needs.

“Catastrophically injured people deserve choice about their care and where they live,” he said.

“A NIIS model which doesn’t have the choice of common law for care denies injured people the funds to set themselves up where and in a way that is best for them.”

Mr Potts said removing common law rights has proved disastrous in other jurisdictions.

“New Zealand did this with their accident scheme, and it only survives by regular – and massive – injections of taxpayer money,” he said

“South Australia removed common law rights in a similar workplace related scheme and it went into rapid financial decline.

“Bringing common law back was a key part of making it financially viable again.”

Mr Potts said the model of implementing the scheme in Queensland should be one which best allows an injured person to retain their dignity and have the most choice about their lives.

Dog fighting

The Palaszczuk Government has no tolerance for any form of animal cruelty.

We have already shown, with the prosecutions arising from the Task Force/RSPCA investigation into cruel practices in the greyhound racing industry, that we can effectively tackle these issues.

We are also introducing legislation to stamp out puppy farms.

We are determined to stop the callous and cruel exploitation of animals.

Dog fighting is barbaric and reprehensible.

Under current legislation anyone who takes part in an organised dog fight, even by simply attending one, can go to jail for a year.

Agriculture Minister Leanne Donaldson will be meeting the RSPCA as a matter of urgency and is offering every assistance to the current police/RSPCA investigation.

M1 Southern Upgrade (Varsity Lakes to Mudgeeraba)

The M1 is part of the National Land Transport Network, for which the Australian Government has primary funding responsibility.

Any upgrade of the M1 is subject to a joint 80:20 funding arrangement between the State and Federal Government. Just as the Federal Government has committed to upgrade the M1 on an 80:20 basis across the border in New South Wales.

This is consistent with 80:20 funding elsewhere in Queensland such as, the Gateway Upgrade North project, the Toowoomba Second Range Crossing, the Bruce Highway and the Warrego.

A final business case for the upgrade was submitted to the Federal Government in February

The Turnbull Government has all the documentation they need to make a funding decision on the M1.

The Turnbull Government should stop taking Gold Coast motorists for granted.

Background

- Karen Andrews MP says the state government has failed to provide a final business case for the southern M1 upgrade
- This is incorrect – a final business case was submitted in 23 February 2016.
- The State Government funded the business case entirely - \$1.2 million
- Minister Bailey has previously met with Ms Andrews to discuss this project

SEQ Cross River Rail project

With South East Queensland's population set to grow to 4.9 million by 2036, Cross River Rail is the state's number one infrastructure project.

The Palaszczuk Government is determined to ensure this critical infrastructure project gets the green light, and has announced it will establish a delivery authority to ensure the project is no longer hostage to political point scoring.

We want every level of government to have a seat at the table to support the delivery of this vital transport infrastructure so that our transport network will have capacity to meet growing demand for services into the future.

But the Government also understands that we need to explore innovative funding models and partnerships to ensure this critical infrastructure project can be delivered.

As the business case gets developed the full host of value sharing options will be discussed and delivered.

Over the next 20 years rail demand in SEQ will increase threefold which is why we need to build Cross River Rail to boost network capacity in our region and address capacity constraints identified in the Australian Infrastructure Audit.

Cross River Rail will benefit every commuter in the south east corner from Gympie North to the Gold Coast and will ensure we can increase services on the entire SEQ rail network during our busiest times and minimise overcrowding on platforms and trains.

The Palaszczuk Government wants to see Cross River Rail built and will establish a delivery authority to ensure the project cannot continue to be kicked around like a political football.

The former LNP Government blew \$85 million on their fantasy BaT tunnel project and they walked away from more than \$715 million in funding on offer from the Federal Government which would have enabled this project to start years ago.

Background

- On Thursday 7 April the Acting Premier and Minister for Transport unveiled the new 10.2 kilometre Cross River Rail alignment and plans to establish a Delivery Authority.
- A delivery authority council would all partners – including private capital – to invest together and build Cross River Rail.
- Over 100 design and alignment options have been investigated as possible solutions to ease rail congestion, culminating in Cross River Rail being the preferred solution. The new Cross River Rail design provides superior capacity and connectivity to the north and south, as well as opportunities for future expansion of the SEQ rail network. With a shorter route, fewer construction impacts and fewer operational risks, Cross River Rail is also the most cost effective solution.
- The Department of Transport and Main Roads is currently proceeding with the preliminary evaluation stage for the project. Building Queensland is leading the development of the business case.
- The updated business case based on the new alignment would be completed in mid-2016.

TAIHATIAN PRINCE -- MOREHU-BARLOW

Recovery action continues to be monitored by the appropriate agencies in Queensland in relation to Joel Morehu Barlow.

I make no further comment on this matter.

BACKGROUND:

Morehu-Barlow is eligible to apply for parole release from December.

This does not mean he will necessarily be granted parole from this date and he will need to apply to the Parole Board as per the usual process.

Agencies (including CCC and Public Trustee Qld and ODPP) are continuing to monitor recovery action in relation to Morehu-Barlow, believed to be more than \$8 million outstanding.

VET SECTOR MEETS SKILLS DEMANDS IN QLD

The Palaszczuk Government aligns state training funds, including funds received under the National Partnership, with areas of skills shortages through its demand-driven VET Investment Plan and Queensland Training Subsidies list.

The Subsidies List is periodically revised to reflect changes in industry skills demands and areas of identified skill shortages.

The Palaszczuk Government has recently established Jobs Queensland to provide advice on areas of particular training and skilling need.

We are, however, seriously concerned about future federal funding.

McVeigh would have to resign once the Federal election is called, triggering a bi-election in Toowoomba South.

ONE PUNCH CAN KILL WORKSHOPS

We made a commitment to ensure that every Year 12 student understands that one punch can kill.

Starting this school term, the Matthew Stanley Foundation and Queensland Homicide Victims Support Group will begin workshops in state schools.

We recognise that our schools have an important role to play – in partnership with parents – to help change community attitudes to violence.

These information sessions will educate our young people about the risks and dangers associated with alcohol-fuelled violence and that one punch can kill.

BACKGROUND:

We are investing more than \$430,000 to roll-out the One Punch Can Kill information sessions in high schools in 2016.

The sessions will equip students with the skills they need to develop respectful and ethical relationships free of violence and engage in responsible decision making.

Our anti-violence program in Queensland state schools also includes:

- Respectful relationships education program from Prep to Year 12 made available to all schools; and
- Alcohol and other drugs education program in Years 7 to 10, with the program mandated in Years 11 and 12.

Flu Vaccine

At the COAG meeting of Health Ministers in Perth last week, Queensland Health and Ambulance Services Minister Cameron Dick called for an independent inquiry into the supply and procurement of vaccinations in Australia.

Vaccination is a critical public health issue.

The current system of vaccination supply and procurement is a mix of federal and state responsibility across a range of programs.

The Health Ministers also agreed to Queensland's proposal that steps should be taken to co-ordinate the use and control of medicinal cannabis across state and territories.

There has been a lot of movement in relation to medicinal cannabis both last year and this year. Mr Dick said it was important that state and territories work together, share information and where possible adopt a coordinated approach to this issue.

Ten Eyewitness News Queensland 5:00pm (Ten Network)

1st Story: There are 'major' traffic delays on the Bruce Highway tonight. A crash has stopped traffic in both directions.

2nd Story: Clive Palmer has 'ridiculed' a recommendation he be investigated by the corporate watchdog over the collapse of Queensland Nickel. Palmer released documents that he says prove he did nothing wrong. According to the administrators' report- Palmer spent \$5 million of the refinery's money on luxury cars. Treasurer Curtis Pitt says, "if the money hadn't been taken out, there would have been another four or five years' worth of work opportunity". Palmer released the Queensland Nickel Joint Venture Agreement today. The Treasurer wants to sue Palmer and says, "we aren't, as a Government, going to let Clive Palmer get away with it". Opposition Leader Lawrence Springborg says, "Mr Palmer claims great assets in a very, very verbose way. This would provide an opportunity to be able to test that and to see if he could be held personally accountable". Workers are waiting for the Federal Government to step in and pay their entitlements. Federal Employment Minister Michaelia Cash says at \$73 million, 'this would be the largest claim in the history of the scheme'. Deputy Premier Jackie Trad says, "there are projects that are ready to go in Townsville like the Townsville Stadium that's just waiting for the Federal Government to make a commitment".

3rd Story: Lawyers for bank robber Brenden Abbott have lodged an appeal against plans to extradite him to Western Australia.

4th Story: A state by-election could be held next month following the resignation of Toowoomba South Member John McVeigh, who will run for the Federal seat of Groom. Mr McVeigh says, "can I say that it has been an absolute honour" and, "I've got a number of constituent matters to finalise and this timeframe of just over two and a half weeks allows me to do that very comprehensively". Opposition Leader Lawrence Springborg says, "there can be no justifiable reason other than silly political games for the Premier to delay the calling of a by-election". Acting Premier Jackie Trad says, "the calling of an election is the prerogative of the Premier". Premier Annastacia Palaszczuk returns from her trade mission to China this weekend. Ms Trad says, "quite clearly we are not interested in Queenslanders going back to the polls another time this year".

5th Story: The first of three Highgate Hill homes at the centre of heritage protection dispute has been torn down. The Queensland Heritage Council decided the houses didn't meet the threshold of heritage significance.

6th Story: The father of a murdered Melbourne toddler has spoken out, after the girl's mother was charged with her murder.

Others:

- Around 100 students have marched through Brisbane to protest the Turnbull Government's plan to slash University funding.
- Gold Coast City Council has plans to install pop-up urinals in Surfers Paradise. Some nightclub owners are opposed to the plan.
- Brisbane City Council is on the hunt for the official town crier.
- A pilot program in New South Wales will enable people at risk of abuse to find out if their partner has a history of violence.

Seven News Brisbane 6:00pm (Seven Network)

1st Story: Motorists are being warned to experience huge delays tonight after serious accidents on the Bruce Highway at Bells Creek near Caloundra and also on the Ipswich Motorway.

2nd Story: Drivers could pay an extra \$80 on their vehicle registration to cover the cost of a new national insurance scheme for accident victims. The RACQ has called on the Palaszczuk Government to put a three year freeze on the current fees. Compulsory Third Party insurance only kicks in for about half of all traffic accidents, so the Government wants to sign-up to the National Injury Insurance Scheme to fill the gap and support everyone injured or severely disabled in an accident. Queensland Treasurer Curtis Pitt says, "Both options will come at a cost to Queensland motorists, but both options will of course cover motorists for lifetime care and support." I spent Monday/Tuesday in Canberra with the Dept of Industry national radioactive waste management project team (I sit on their independent advisory panel) and although the Feds were understandably coy a couple of things seemed pretty clear to me

(i) I expect that Minister Frydenberg will announce a short list of (most likely) two sites of the current six to be advanced to phase two for detailed study and community engagement sooner rather than later. Unlike this time last week I now expect this announcement to be made before the federal election.

(ii) I think that the Qld site will be one of these. The Feds know the Oman Ama site is contested but seem confident that there is sufficient local government and wider community support for it to progress. When pressed re the Qld state legislation they gave the clear sense that they believe the state government, while not supporting – will not actively oppose. In particular they seem confident that Queensland will not play the plebiscite card.

Please see recent attached letter from the Premier's office to a leading site critic. It is good and welcome correspondence but the reference to Queensland's constitutional constraints combined with no reference to the plebiscite is concerning in the above context.

I appreciate that you are pushing what you can re this but wanted to alert you to my growing sense that the eye of Sauron seems pretty locked on SE Qld and the clock is ticking loud.

Thank you for your email of 7 March 2016 regarding a Federal Government nomination of Oman Ama as a possible site for a national radioactive waste management facility. I have been requested to reply to you on behalf of the Premier.

The Queensland Government was first formally notified on 16 November 2015 that the Honourable Josh Frydenberg MP, Federal Minister for Resources, Energy and Northern Australia, had approved six site nominations for a national radioactive waste management facility including Oman Ama. The Federal Government is now in the process of making a decision about considering a smaller number of these sites, before a final decision about the preferred site is made.

This proposal is opposed by the Queensland Government. The Honourable Dr Anthony Lynham MP, Minister for State Development and Minister for Natural Resources and Mines has already written to Minister Frydenberg advising that the Queensland Government does not support, in any circumstances, any Queensland location being utilised for radioactive waste storage. Minister Lynham has also made it clear that any Queensland site should be withdrawn from the Federal Government's shortlisting process.

The State's *Nuclear Facilities Prohibition Act 2007* seeks to protect the health, safety and welfare of Queenslanders by prohibiting the construction and operation of particular nuclear reactors and other facilities in the nuclear fuel cycle. This includes facilities for storing nuclear material and the disposal of nuclear material from such facilities. However, as you rightly point out, Queensland is constitutionally constrained in its capacity to influence a Federal Government process operating under Federal law.

Again, thank you for raising your concerns with the Premier.

LNP continues to peddle lies about merger's impact on business owners

Opposition making unfounded claims about division not in existence

The ETU has called on the LNP to apologise to the state's electrical workers for lying about the impact of the Energex/Ergon merger on business owners in the renewable energy sector.

The LNP and Masters Electricians (MEA) have been recklessly and irresponsibly whipping up hysteria about the impact of the Energy Services division to be created as part of the power merger.

The LNP and MEA have been peddling the unfounded claim that the division will directly compete with electrical businesses.

ETU State Organiser Stuart Traill said the Energy Services division would not compete with private businesses, "and anyone making such claims is either making an uneducated guess about the outcome of the merger, or purposefully misleading the public for purely political ends."

"This stands in stark contrast to the LNP who sacked over 2000 energy workers and increased power bills by over 33% while in office."

Mr Traill said MEA would better serve their members by seeking discussions with the government to discuss their members' issues, instead of grandstanding with the Opposition in the Murdoch media.

"We demand the LNP apologise for pulling such outrageous claims about the merger out of thin air," he said.

"MEA have sold out their membership base by becoming complicit in this strategy. Although that's not surprising since they are Liberal lap dogs.

"We encourage MEA members to resign and come talk to the ETU. We will look after their interests much better.
