**Direction under the *Queensland Rail Transit Authority Act 2013***

On 2 October 2018 we were advised that the Queensland Rail Board intends to make performance payments to Queensland Rail staff for the financial year ending 30 June 2018.

Queensland Rail has committed to implementing the recommendations from the 2017 *Queensland Rail Train Crewing Practices Commission of Inquiry* (COI) and the Fixing the Trains Implementation Plan. A number of key performance indicators were not met in 2017-18. Just as importantly, key strategic objectives relating to improving customer experience by restoring a reliable and robust full service timetable have not been met.

We appreciate progress has been made in some areas, including successful delivery of the 2018 Commonwealth Games Transport Plan. However, Queensland Rail continues to face significant challenges in recruiting a surplus of train crew, reducing overtime to sustainable levels, restoring the timetable to pre-October 2016 levels, and rebuilding public confidence in the Citytrain system.

We acknowledge that under the terms of the *Corporate Governance Guidelines for Government Owned Corporations (Version 2.0)* (GOC Guidelines), performance payments are commonly at the discretion of Boards. However, in light of the above and given the extraordinary circumstances experienced since 2016, we consider the payment of executive bonuses in relation to the 2017-18 financial year would be inconsistent with community expectations.

The GOC Guidelines state that remuneration for senior executives should aim to ensure a balance between public accountability and transparency and the need to attract high calibre employees, and that GOCs must be properly managed on behalf of their ultimate owners, the people of Queensland.

Two years on from the introduction of the new Citytrain timetable on 4 October 2016, there needs to be greater focus from the Queensland Rail Board and Executive Leadership Team on restoring a full-service timetable and implementing the remaining COI recommendations. Queensland Rail must:

- remain focussed on ensuring rail services are restored to the levels required to meet the demand of customers, with a sufficient pipeline of train crew to sustain these levels into the future;
- be committed to improving organisational capability to support the delivery of a modern, efficient railway; and
- have unwavering commitment to improving customer focus.

To facilitate this, we have issued a Direction under the *Queensland Rail Transit Authority Act 2013* instructing Queensland Rail not to pay any performance payments to the Chief Executive Officer or Queensland Rail staff for 2017-2018. A copy of the Direction is enclosed.

The Palaszczuk Government committed to fixing the trains and transforming public transport to deliver better outcomes for Queenslanders. We will continue to work with Queensland Rail, the Department of Transport and Main Roads, and the Citytrain Response Unit to deliver our customers a modern, efficient and reliable public transport system that meets their needs now and into the future.

**Direction under the *Queensland Rail Transit Authority Act 2013***

I refer to your letter dated 2 October 2018 attaching a Direction under the *Queensland Rail Transit Authority Act 2013*.

Queensland Rail's Board under my role as Chair has maintained a constant and strong focus on implementing the recommendations from the 2017 Commission of Inquiry. I am proud of what has been delivered to date and I refer you to my letter dated 27 August 2018 setting out the achievements. Of note is the implementation of 17 of the 31 recommendations in accordance with the original schedule.

Turning to the matter of the performance payment that the Board had proposed paying, this performance payment is a key remuneration component of the individual contracts with 384 leaders of the business. The Board set the performance criteria against which individual performance would be measured at the start of 2017/18 financial year. These criteria are all contained in the 2017/18 plans submitted to government. The Board then assessed the delivery of performance at the end of the year. I attach a summary Fact Sheet of the performance criteria and outcomes. I spoke with the Minister three times about the performance payment in recent months and the direction it was heading, noting each time that the performance payment assessment was at the discretion of the Board. Furthermore, I committed to inform the Minister of the outcome of the Board deliberations, which were only concluded at its meeting last Friday 28 September, before a payment was made, which I did yesterday at my first opportunity.

In its deliberations, the Board considered the performance of the business against the criteria set for participants and took into account the outstanding contribution from many people across the business towards the successful outcome delivered for the Commonwealth Games. The Board also took into consideration the significant contribution employees made towards stabilising the business since the failed timetable implementation in October 2016. For example, the adverse trend in SPADs has been arrested; significant improvement was achieved in employee and public safety statistics; the delivery of on-time running performance; no reduced service levels in numerous recent stress periods; driver overtime was reduced by 20%; robust forecasting of supply and demand of traincrews which is actively used in business decisions; and a reduction in the duration of driver training by 30%.

The Board also took account of the fact that the leadership team has actively supported and made a significant contribution to the Cross River Rail project, facilitated a seamless handover of the ETCS project, and had a major input into the Rail Network Strategy which should be the blueprint for the SEQ network for the next 10 years. None of these activities were contemplated at the start of the 2017/18 financial year but all were embraced by dedicated employees. Many employees have worked extraordinary hours during the past 12 months.

The Board's focus has also been to change the culture of Queensland Rail and rebuild the business. To that end we have added new senior leadership to the team over the past 12 months, none of who were with the business when the timetable failed in 2016 and the Board was looking to reward their contribution. It is paramount that the business continues to attract and retain capable people as part of its culture change.

I believe the Board has acted responsibly and fairly to the participants in the performance payment scheme. To not make a payment for this financial year. Part Exempt Sch.3(2)(1)(b) Reveal Cabinet consideration

is not consistent with the performance cultural change that the Board is driving. When a significant contribution is made then employees should be rewarded fairly. I understand some people external to the business might question the merit of a performance payment, but in delivering a multi-year change program it is important to acknowledge the individual contributions along the journey as that is often when the "heavy lifting" is done.

You will recall that the Board decided to pay no performance payment to its employees in the 2016/17 financial year, the year of the "failed timetable". This was well understood by the employees at the time because the business had let its customers down. Your decision to issue a Direction on the performance payment outcome for 2017/18 will no doubt come as a disappointment for many employees, particularly when they heard about the decision via the media, when all have worked extremely hard to recover and stabilise the business.

In respect of the Ministerial Direction itself, under (1) b) you have asked for confirmation of the Board's proposed course of action to implement the direction. I can confirm that I have instructed the CEO not to pay any performance payments to any of its participants for the 2017/18 financial year.
