

Vehicle Standards Instruction (Light 26.0)

Certification of pre-1989 imported vehicles

Released August 2014

As part of Queensland Government's commitment to reducing red tape and regulation, the Department of Transport and Main Roads' (TMR) will introduce changes to certification requirements for newly imported vehicles that were manufactured prior to 1 January 1989. These revised requirements will commence from 1 October 2014.

Under the current system:

- Imported vehicles built prior to 1969 (pre-ADR vehicles) have to meet the requirements of the *Transport Operations (Road Use Management—Vehicle Standards and Safety) Regulation 2010* and require certification to the LO8 section of the *Queensland Code of Practice – Vehicle Modifications*.
- Imported vehicles built between 1969 and 1971 (2nd Edition ADR vehicles) have to meet the applicable requirements of the 2nd Edition Australian Design Rules and also require certification to the LO8 section of the *Queensland Code of Practice – Vehicle Modifications*.
- Imported vehicles built between 1972 and 1988 (2nd Edition ADR vehicle) have to meet the applicable requirements of the 2nd Edition Australian Design Rules and require certification to the LO1 section of the *National Code of Practice for Light Vehicle Construction and Modification*.

From 1 October 2014, the type of certification required will be aligned to match the vehicle standards the vehicle is required to meet. This will mean:

- For vehicles built prior to 1969 (pre-ADR vehicles) certification by an Approved Person will no longer be required and the necessary vehicle standards requirements will be assessed by an Approved Examiner during a Safety Certificate inspection.
- For vehicles built between 1969 and 1988 (2nd Edition ADR vehicle) certification to the LO1 section of the *National Code of Practice for Light Vehicle Construction and Modification* will be required.

Please note: A minor variation will be included in the LO1 section that exempts seatbelt requirements for vehicles built prior to 1972.

- The LO8 section of the - *Queensland Code of Practice – Vehicle Modifications* will be repealed.

Approved Person Accreditation

As this change will result in the removal of the LO8 modification code, there will be some minor impacts on Approved Persons, namely:

- Approved Persons currently accredited for the LO8 code will see this code removed when your accreditation is next renewed.
- A revised version of the *Queensland Code of Practice – Vehicle Modifications* will be produced that no longer includes the LO8 section.
- A revised version of the LO1 section of the *National Code of Practice for Light Vehicle Construction and Modification* will be produced that includes the minor local variation.

Registration Requirements

This change will not alter any other registration requirements for these vehicles, including the requirement for a safety certificate.
