


Transport System Planning Program (TSPP)

- QTRIP provides a firm funding commitment for two years and indicative funding for the remainder of the program.
- TSPP budget is \$67m in 2016-17.
- Seeking to procure \$22m of services from the market in 2016-17.




Transport System Planning Program


 The TSPP is a "one integrated transport system" program of planning activities that collectively plan for future transport system outcomes.



Funds, delivers and manages TMR's planning and investment activities.




Encompasses all modes and all networks across Queensland, both infrastructure and services.




Ranges from strategic planning through to business case development.

Our aim: to continue building on improved communication and transparency with industry.


Our approach:





Procurement value by Transport and Main Roads' region




Procurement value by time to market
