## Ten Eyewitness News Queensland

### 5:00pm (Ten Network)

1<sup>st</sup> Story: Emergency crews have spent the afternoon fighting a fire at a Rocklea car wreckers. The threat of toxic smoke was the biggest concern.

2<sup>nd</sup> Story: The bomb squad has been called in to inspect two suspicious vehicles parked on Felix Street in the CBD. After being placed in lock-down for more than three hours, the area has now been cleared.

**3<sup>rd</sup> Story:** A father planned to abuse his baby before she was even born, a court heard today. The man has been remanded in custody and faces up to fifteen years in jail.

4<sup>th</sup> Story: A Gold Coast man accused of abducting his two year old grandson remains behind bar.

5<sup>th</sup> Story: Bob Katter is under fire over his new campaign video, which shows him 'shooting' two men in ALP and LNP shirts. Katter refuses to concede the timing is 'insensitive', and suggested he didn't know about the Orlando shooting.

6<sup>th</sup> Story: Shadow Health Minister John-Paul Langbroek has been asked to 'explain himself' after making 'rude hand gestures' in Parliament. Transport Minister Mark Bailey says, "I think it's really disrespectful of Parliament". Opposition MZPs claim the Government is trying to make the issue bigger than it seems. Opposition Leader Tim Nicholls says, "I will, of course, be reinforcing to MPs the importance of maintaining appropriate standards in the house". It took the focus away from Mr Nicholls' budget reply. To boost jobs, an elected LNP would provide \$5,000 incentives to businesses who hire an additional apprentice who finishes their training, \$500 for apprentices to buy tools, and \$4,000 grants to businesses who take on young, unemployed Queenslanders. Mr Nicholls says, "creating opportunities for up to 20,000 new jobs". Treasurer Curtis Pitt says, "the leader of the Opposition seems like a goldfish swimming around in a bowl, he's come around the other side again, he's forgotten that he sacked everyone".

### Others:

• Ergon and Energex will join forces to become Energy Queensland from next month. The Government insists there will be no forced redundancies, but small businesses are concerned it will affect their work. The merger, announced in Parliament last night, will save the Government up to \$560 million by cutting duplication in admin and management. The head office will be based in Townsville. Energy Minister Mark Bailey says, "no forced redundancies, that's our clear policy. We will work with the workforce when it comes to change".

 Deadly weapons including a pen gun have been seized in a bikie raid on Brisbane's north side by Taskforce Maxima.

 Thirty-five new CCTV cameras will be installed in the CBD and Fortitude Valley.

## Seven News Brisbane 6:00pm (Seven Network)

**1st Story:** Several streets in Brisbane's CBD were shut down this afternoon after reports of suspicious vehicles parked outside Commonwealth offices. No charges have been laid by Police and the cars have now been moved.

2<sup>nd</sup> Story: Fire crews attended a toxic blaze at a car yard in Rocklea today. It took more than an hour for the fire to be excinguished.

3<sup>rd</sup> Story: Australia's biggest private health insurer Medibank stands accused of leaving members hundreds or possibly thousands of dollars 'out of pocket'. The ACCC says Medibank cut benefits to boost profits, but kept the changes secret.

4<sup>th</sup> Story: Police are hunting a man who robbed an Upper Coomera convenience store at gunpoint early this morning.

5<sup>th</sup> Story: Jean Madden, the former CEO of Street Swags, has called her dismissal by the charity's board 'unlawful', saying she did not misappropriate any funds.

6<sup>th</sup> Story: LNP frontbencher John-Paul Langbroek has been caught on camera making 'lewd gestures' in State Parliament. Yesterday an LNP backbencher was reprimanded by Speaker Peter Wellington due to 'silly' hand movements. Speaking of the lewd gestures by Mr Langbroek, Education Minister Kate Jones says "I believe it is a reflection on the Chair". State Opposition leader Tim Nicholls responded to the controversy, saying "I think there is an appropriate behaviour, of course, that all MPs need to follow".

Others:

 An Interactive ANZAC exhibition will open at the Brisbane Convention & Exhibition Centre tomorrow.

• A 36 year old man, accused of being the worst online predator in Queensland, has been released back into the community. The man was sentenced to six months in prison for breaching a domestic violence order today, but was released due to time already served.

• Brisbane City Council has announced 35 new high-definition security cameras will be installed in the Brisbane CBD, at a cost of almost \$3 million dollars to ratepayers. Last year Council cameras caught almost 5,000 incidents in Brisbane City.

• Five guns have been seized from the Kelvin Grove property of an alleged 41 year old Nomad motorcycle gang member.

• New RACQ data has revealed the Brisbane suburbs with the highest rates of break-ins. Macgregor, Robertson, Sunnybank and Sunnybank Hills have the most home robberies in south east Queensland according to RACQ insurance claims.

**1st Story:** There are allegations that Surfers Paradise Police unlawfully arrested a man then deleted his phone footage of the encounter. 

RQYS have applied for Category I moorings in Deanbilla Bay for the whole of the south of the bay. Essentially this is an unprecedented privatisation of the the marine park.

Category 1 moorings are different to other moorings in that they allow RQYS total control of the mooring area. Other yachting people have raised concerns http://tradboatsqld.asn.au/deanbilla-bay-proposal-2016/ (note this link includes an objection sent to Minister Bailey re the moorings, copied on word doc below)

The only other Category 1 moorings in QLD are at Southport and Whitsunday islands(?) and those have been very contraversial, including among yachting fraternity themselves.

Why does RQYS need this level of control?

Given the exclusivity and control of area by Cat 1 moorings, it's hard to see how they could be approved on native title grounds alone.

RQYS did not consult with Traditional Owners and yet the sea area is within non-exclusive native title. There is also a highly significant cultural site at Adams Beach which immediately adjoins the area of the bay for which the mooring application has been made. Not many sites get to be registered on the Department of Aboriginal and Torres Strait Islander Partnership register, but this one has.

The Quandamooka People have already invested in eco\cultural tourism venture at the Adams Beach compground adjoining the bay. The potential impacts on Quandamooka current and future business plans for the area should be taken into account when assessing the mooring application and indeed the whole of the RQYS proposal for Deanbilla Bay.

RQYS have, or plan to take over the lease held by Sibelco for land adjoining Deanbilla bay (see attached pdf for location) According to Courier Mail article (below), Sibelco has already passed the lease to RQYS. Is this true?

If so the relevant Minister has the option to refuse to renew the lease. Or at point at which RQYS applies for change of use, a proper assessment of what is in the public interest for this prime waterfront site should be undertaken.

The attached pdf gives the scale of the RQYS project has for the bay (see page 9) - sailing school, regattas, accommodation etc. Sailing school for kids?-- it would seem Deanbilla Bay is too shallow to be practical. When the tide goes out there is more than 100 meters of mudflat. Sailing school begins and ends at set times. So what happens when the tide is out? How will the yachts get to water?

There are questions about what the real intent of RQYS is. Conversion to freehold further down the track? Perhaps a marina? Private residential units ?

Sibelco holds other leases associated with Dunwieh harbour area, including what is currently the loading dock for the minerals that are shipped off island. These will all be prime development areas.

Local member Mark Rohinson is already calling for 50 million development including the RQYS project http://www.redlandcitybulletin.com.au/story/3835199/straddic-doomed-without-50-million-harbour-boost/ Mayor Karen Williams in favour of the Deanbilla development http://karenwilliams.com.au/media/comments/sailing-centre-of-excellence-to-the-redlands-moreton-bay

RQYS previously applied to buy the Little Ships cub facility at Dunwich. There was talk of building a marina at the site. RQYS was not successful in buying Little Ships Club. Next thing they are looking at Deanbilla Bay



## Native title manager slams Royal Queensland Yacht Squadron for failure to consult on Deanbilla Bay sailing school plan

The Royal Queensland Yacht Squadron's plan to open a sailing school on North Stradbroke Island has sparked controversy with the island's traditional owners seemingly keep out of the loop.

The Manly-based squadron has taken over a lease on land at Deanbilla Bay, near Dunwich, from mining company Sibelco to establish a sailing destination for its club.

General manager Shawn Ket said the registration confirmation of the lease transfer from Sibelco to Royal Queensland Yacht Squadron (RQYS) was approved on Monday, clearing the way for the opening.

Mr Ket said the RQYS hoped to host junior sailing classes within "a matter of weeks".

"We're thrilled at the opportunity to be able to provide a second sail school and regatta centre," he said.

"We really believe it's going to be absolutely a brilliant way to improve participation in the sport of sailing."

But Quandamooka Yoolooburrabee Aboriginal Corporation chief executive officer Cameron Costello said the RQYS had not consulted with them on native title rights on the waters of Deanbilla Bay. He said the lack of consultation was "not how you do business with traditional owners".

"To continue to try to progress the project without engaging with us is not an appropriate way to do business with people who have property rights (traditional owners)," he said.

"The Quandamooka People's native title commences as soon as you step into the water on that site."

Mr Costello said there was a "massive consultation process" for North Stradbroke Island's Economic Transition Strategy, but the RQYS had not been part of that process.

Mr Ket said the squadron had emailed and phoned Mr Costello and were awaiting a response.

However, Mr Costello said he first heard of the RQYS's plans from the media in March. He said the squadron emailed his organisation in April but "an email to admin doesn't count as consultation".

"Attempting to contact us once after an announcement has been made is not how you do business with traditional owners," Mr Costello said.

He said Quandamooka Yoolooburrabee Aboriginal Corporation was disappointed the transfer had occurred and added the term of the lease had not yet expired.

"The long-term use of the site has yet to be officially decided and we'll be strongly advocating to the State Government that it should not be to use native title waters without native title consent," Mr Costello said.

"This (transition) is about the economic development of Aboriginal and island-based residents and unless it's at least a joint venture with the Quandamooka People, it should not be even considered."

RQYS general manager Shawn Ket said the organisation had been transparent with its plans for the site and "could not be aware of all the political sensitivities that might exist".

"We've worked very closely with the state government and the local government and Sibelco as the parties who are formally required to be involved in the transfer," he said.

Mr Ket said the Deanbilla Bay site would be used for sailing lessens and regattas and bring "hundreds and even thousands" to the island in sports tourism.

"We're trying to create a great sailing centre for Stradbroke Island," he said.

The school would employ residents where practical, and benefit the island's cafes and accommodation, including QYAC-managed Straddie Camping.

"We would love to talk to the Quandamooka People about the right naming ceremony and respectful views to be considered on North Stradbroke Island," Mr Ket said.

While a Department of Mines and Natural Resources spokesman said it received advice that "the land in question is not included in the Quandamooka Yoolooburrabee Aboriginal Corporation (QYAC) indigenous Land Use Agreement", Mr Costello said Deanbilla Bay's waters were included in native title.

He added the land was "extremely rich" in cultural heritage and should be protected.

The Quandamooka Yoolooburrabee Aboriginal Corporation had earmarked the site for eco-cultural tourism and to expand the Land and Sea Ranger program and had liaised with the State Government since 2014 on the lease status.

- 1. RQYS have proposed the takeover of the Sibelco Ltd lease on Stradbroke Island to establish a sailing school.

## 80:20 Federal Funding in Queensland

The purpose of this document is to provide the Minister of Main Roads, Road Safety and Ports with recent examples of 80:20 federal funding arrangements for road projects in Queensland and New South Wales to provide background to funding discussions with key stakeholders in relation to the M1 Pacific Motorway – Gateway Motorway Merge (southbound) and M1 Pacific Motorway Mudgeeraba to Varsity Lakes (six-laning) projects. Noting, there are other funding arrangements in place for many other road project commitments in Queensland.

Current QTRIP projects - Examples of 80:20 funding arrangements

- Bruce Highway many individual projects as part of the \$8.5 billion, 10-year program (\$6.7 billion federal funding, \$1.8 billion state funding). Projects and packages in the program are generally funded 80:20, with some exceptions. Key projects funded on an 80:20 basis are:
  - o Caloundra Road to Sunshine Motorway upgrade (\$1.134 billion)
  - o Mackay Ring Road (\$565 million)
  - o Haughton River and Pink Lily Lagoon upgrade (\$515 million)
  - o Edmonton to Gordonvale Duplication (\$481 million)
  - o Maroochydore Road Interchange (\$187 million)
  - o Townsville Ring Road (\$200m)
  - o Yeppen floodplain (\$170m)
  - o Rockhampton northern access upgrade (\$121m)
  - Cattle & Frances Creeks upgrade (\$174m)
  - o Bruce Highway Safety Package (\$400m)
  - Cooroy to Curra, Section C (\$384.2m)
- Warrego Highway Upgrade Program \$635 million for 15 projects/packages, over 5 years. (\$508 million federal funding and \$127 million state funding)
- Gateway Upgrade North \$1.143 billion (\$914.18 million federal funding and \$228.54 million state funding)
- Cape York Regional Package \$260.5 million (\$208.4 million federal funding, \$52.1 million state funding)

Summary of 2016 federal election commitments for Queensland – Coalition *80:20 funding arrangement* 

- \$155.8 million (80 per cent) to Queensland Northern Australia Roads Programme projects including:
  - o \$60 million (80 per cent) Capricorn Highway duplication between Rockhampton and Gracemere
  - o \$42.6 million (80 per cent) Kennedy Developmental Road (including Hann Highway)
  - \$33 million (80 per cent) Flinders Highway pavement and structures upgrades between Townsville to Richmond

- \$10 million (50 per cent) Mount Lindesay Highway safety and upgrades (Browns Plains to Beaudesert)

### Funding arrangement to be determined

- \$150 million towards the Townsville Eastern Access Rail Corridor (TEARC) project. *Next* steps including funding arrangements to be discussed with DIRD.
- \$100 million towards sealing the Outback Way from Laverton in Western Australia to Winton in Queensland. Project specific details including Queensland's allocation will be confirmed with Department of Infrastructure and Regional Development.
- \$20 million (funding split to be determined with DIRD) towards Philip Street (Gladstone -Benaraby Road) in Gladstone
- \$250,000 (funding split to be determined with DIRD) towards a preliminary study to examine linking the Melbourne to Brisbane inland Rail project to the Port of Gladstone
- \$3.5 million (funding split to be determined with DIRD) towards the Shore Street West and Wellington Street intersection (Ormiston).

Current NSW projects - Examples of 80:20 funding arrangements

 \$3.46 billion on an 80:20 basis to construct the final section of the Pacific Highway duplication in New South Wales from Woolgoolga to Ballina by 2020, as part of an overall \$5.64 billion program for works on the same motorway, across the border in New South Wales. TOPIC: History of federal funding arrangements since early 1990s

### Pre-AusLink 2004

□ Former National Highways – 100 per cent federally-funded.

□ Tolled facilities on National Highways not funded; eg. Gateway Motorway National Highway included Motorway (Eight Mile Plains to Pine River), but excluded Gateway Bridge franchise area.

□ Generally 50:50 funding agreed for off-National Highway network projects funded under the Roads of National Importance program eg. early Pacific Motorway interchanges.

### AusLink 2004

□ Redesignation of National Highways to form part of the National Land Transport Network (NLTN) and extended to include other key road and rail corridors; eg. Pacific

Motorway (Tugun-Gateway Motorway); Port of Brisbane Motorway and rail from Port of Brisbane through Acacia Ridge to NSW border; Townsville Ring Road; Flinders Highway (Townsville to Cloncurry, including Townsville Port Access Road); Brisbane-

Townsville rail and Townsville-Mt Isa rail.

□ former National Highways – funded 100 per cent

□ generally capped contributions towards agreed projects on extended NLTN (eg. Tugun Bypass \$120m; Acacia Ridge rail level crossing \$25m).

## Nation Building Program (NBP) 2008-09 to 2013-14

□ Most former National Highway projects were 100 per cent federally funded with some projects funded under an 80:20 arrangement eg. Full upgrade of Ipswich Motorway was a federal election commitment (100 per cent), Mains/Kessels Interchange (100 per cent); six-laning, south of Cairns (100 per cent); upgrade of four interchanges between Caboolture-Caloundra (100 per cent); Cooroy-Curra Section B (80:20); Warrego Highway (Roma-Mitchell) upgrade (80:20).

□ 50:50 funding for projects on the extended NLTN eg. sections of six-laning Pacific Motorway, south of Nerang; Townsville Port Access Road.

□ 50:50 funding for minor off-network road projects eg. sections of Peninsula Developmental Road; section of Wills Developmental Road.

Off-network Moreton Bay Rail Link funded on the following basis:

- Federal - 65 per cent

- State - 26 per cent

- Moreton Bay Regional Council - 9 per cent.

### Infrastructure Investment Programme 2014-15 to 2018-19

□ Move to generally fund all former National Highways on an 80:20 basis – apart from, in Queensland, Ipswich Motorway (Rocklea to Darra) announced by both former Labor and current Coalition Governments at 50:50, negotiations ongoing. (Note, however, duplication of remaining sections of Pacific Highway in New South Wales (part of extended NLTN) is being funded at 80:20.)

□ The former Queensland Government agreed to a minimum 80:20 on future NLTN project commitments, noting, there was an earlier agreement to a one-off arrangement of 50:50 for Bruce Highway (Cooroy-Curra) Section A, which is currently under construction, on a "no precedent basis".

□ The 10-year 'Fix the Bruce' Coalition election commitment was generally based on an 80:20 funding arrangement for Bruce Highway projects, apart from three bulk works packages where a 100 per cent federal funding commitment was specified: – overtaking-lanes – \$100m

- black spots, rest areas and safety upgrades - \$175.2m

- additional targeted road safety improvements - \$128.8m.

The NPA Works Program subsequently listed these bulk works packages, based on an 80:20 funding arrangement.

# Pacific Motorway – Stage 1B Southbound (Gateway Motorway to Rochedale Road

## **Project Scope**

The project focuses on improvements to three kilometres of the Pacific Motorway between Eight Mile Plains and Springwood involving:

- increasing through travel lanes from three to five lanes in the southbound direction
- relocation of the southbound bus only on-ramp to the M1 at Eight Mile Plains to the Underwood Road overpass
- construction of a new four lane Underwood Road bridge overpass
- managed motorways components.

## **Project benefits**

The project is expected to provide the following benefits:

- allow sustainable management of congestion on the Gateway Motorway
- improve freight efficiency and productivity along the Pacific Motorway corridor
- improve travel time reliability for all road users
- improved busway accessibility to and from the Pacific Motorway thereby encouraging mode shift to public transport
- improving safety by reducing the number of crashes that occur on the Pacific Motorway at this location
- Facilitating Logan and Brisbane City Council
   transport planning outcomes
- Maximising the use of the existing transport infrastructure asset, where possible.

By 2026, during the PM Peak:

- The project case will deliver average delays of 3 seconds per kilometre, verse 99 seconds per kilometre for the 'do minimum' base case
- The project case will deliver average travel speeds of 89 kilometres per hour, verses 38 km per hour for the 'do minimum' base case
- The project case will deliver vehicle hours travelled of 778 hours, versus 3,947 hours for the 'do minimum' base case

By 2036, during the PM Peak:

- The project case will deliver average delays of 4 seconds per kilometre, versus 98 seconds per kilometre for the 'do minimum' base case
- The project case will deliver average travel speeds of 90 kilometres per hour, verse 38 kilometres per hour for the 'do minimum' base case
- The project case will deliver vehicles hours travelled of 917 hours, versus 5 441 hours for the 'do minimum' base case.

## Cost

The project has a project cost estimate of \$207 million (P90 Outturn).

# Pacific Motorway – Mudgeeraba to Varsity Lakes (six-laning)

## **Project Scope**

The project focuses on improvements to five kilometres of the Pacific Motorway between Mudgeeraba (Exit 79) and Varsity Lakes (Exit 85) interchanges involving:

- increasing through travel lanes from two lanes to three lanes in each direction
- providing a central median concrete barrier and/or guardrail for the entire length
- lengthening of entry ramps and exit ramps to meet current design standards with provision for managed motorways ramp control
- construction of new northbound Mudgeeraba
   Creek bridges
- providing a northbound auxiliary lane to enable safe weave movements between the Robina Parkway entry ramp and the Link Way exit ramp.

## **Project benefits**

Key benefits from widening the motorway to six lanes include:

- reducing the extent and duration of congestion for the Mudgeeraba to Varsity Lakes section of the Pacific Motorway and increases freight efficiency along the corridor
- reducing the number of crashes on the Pacific Motorway between Mudgeeraba and varsity Lakes interchanges and particular road safety risks
- maximising use of the existing asset where possible and staging improvements to increase the return on investment and reduced maintenance costs
- implementing a scheme including future proofing for a Managed Motorway systems to be integrated at any time

## Cost

Based on a P50 outturn capital cost, the project will require a funding commitment of \$41 million and \$166 million from the Queensland and Australian Governments respectively adopting an 80:20 funding split.

Based on a P90 outturn capital cost, the project will require a funding commitment of \$44 million and \$176 million from the Queensland and Australian Governments respectively.
