## 1 Introduction

This Specification applies to establishment, maintenance and disestablishment of the Contractor's site facilities and establishment, operation, maintenance and disestablishment of the Contractor's camp, where required.

This Specification shall be read in conjunction with MRS01 *Introduction to Specifications*, MRS51 *Environmental Management* and other Specifications as appropriate.

This Specification forms part of the Transport and Main Roads Specifications Manual.

## 2 Measurement of Work

### 2.1 Standard Work Items

In accordance with the provisions of Clause 2 of MRS01 *Introduction to Specifications*, the Standard Work Items incorporated in this Specification are listed in Table 2.1.

Where either of these Standard Work Items is not included in the Schedule of Rates for the Contract, the Work Operations associated with that Work Item shall be deemed to be included in the other Work Items included in the Contract.

### 2.2 Work Operations

#### Item 20101 Contractor's site facilities

Work Operations incorporated in the above item include:

- a) Work Operations listed in Clause 2.1.5 of MRS01 *Introduction to Specifications*
- b) supply and transport of all personnel, plant, equipment and materials including buildings and structures, other than materials required for the construction of the Works or those covered by Item 20102, to and from the Site
- c) hire or purchase of the Site for the Contractor's site facilities
- d) preparation of the Site for the Contractor's Site facilities
- e) all labour, plant, materials and hire associated with the establishment, maintenance and disestablishment of the Contractor's site facilities, including connection, operation and disconnection of communications, power, water, sewerage, garbage disposal and similar services except those covered by Item 20102 if this item is included in the Schedule of Rates for the Contract
- f) obtaining all necessary licenses and permits under relevant legislation

- g) removal of all facilities upon completion of the Contract, and
- h) cleaning up the Site following removal of all items.

**Item 20102 Contractor's camp**

Work Operations incorporated in the above item include:

- a) Work Operations listed in Clause 2.1.5 of MRS01 *Introduction to Specifications*
- b) supply and transport of all personnel, plant, equipment and materials including buildings and structures, other than materials required for the construction of the Works and those covered by Item 20101, to and from the Site
- c) hire or purchase of the camp site, as relevant
- d) preparation of the camp Site
- e) all labour, plant, materials and hire associated with the establishment, operation and maintenance and disestablishment of a camp, including connection, operation and disconnection of communications, power, water, sewerage, garbage disposal and similar services
- f) payment of wages for camp attendant(s), cook(s) and other staff employed for the operation of the camp
- g) obtaining all necessary licenses and permits under relevant legislation
- h) removal of all facilities upon completion of the Contract, and
- i) cleaning up of the camp Site.

**2.3 Rate of payment for Site establishment and disestablishment and/or Camp**

**2.3.1 General**

Payment for Items 20101 and 20102 will be made by the Principal in three stages in accordance with the provisions of this clause.

**2.3.2 Establishment of Contractor's Site Facilities and/or Camp**

Provided that the Contractor is fulfilling all its obligations under the Contract and establishment has been completed, the Contractor shall be paid in the first Payment Certificate 25% of the lump sum amount for the item.

**2.3.3 Operation and maintenance of Contractor's Site Facilities and / or Camp**

Provided that the Contractor is fulfilling all its obligations under the Contract, each Payment Certificate shall include a percentage of the lump sum amount for the item until a total of 90% of the lump sum amount has been paid.

The cumulative percentage entitlement (including previous payments) shall be calculated as follows:

$$E = 25\% + 0.65 * P$$

E = aggregate percentage entitlement

P = Total achieved progress percentage (including approved Extension of Time)

#### **2.3.4 Disestablishment of Contractor's Site Facilities and / or Camp**

The balance of the lump sum amount of 10% for the item will be paid in the Payment Certificate following the date of Practical Completion provided that the Contractor fulfils all its obligations under the Contract for Disestablishment.
