Please note the following:

At the current time Data Analysis (DA) is providing data for all offences with an offence date up to and including 31 October 2018. DA allows a 3 month lag for extracting and providing offence data. This allows for completeness of data and time for the offence notice to be forwarded from Queensland Police Service (QPS) to Transport and Main Roads (TMR) for entering into the system. The 3 month lag includes the 28 day period for the alleged offender to pay or respond to the offence notice. Some offence categories will still be understated due to the prolonged time it takes for these matters to be finalised (e.g. Drink Driving offences).

*The 'total face value' for infringement notices issued is calculated by using the fine amount multiplied by the number of infringement notices issued. This is not the amount received by Transport and Main Roads (TMR), as TMR does not receive all payments for infringement notices issued therefore Data Analysis (DA) is unable to provide data on revenue collected.

**The specific offence location field in Transport Registration and Integrated Licensing System (TRAILS) is a free text field which is not a mandatory field to be completed (i.e. could be left blank). Therefore, there are many discrepancies in this field (e.g. no data at all, different spelling of locations, etc.). This data has been cleansed to meet the requirements of this request. However, in some cases the location information was incomplete or missing, in which case accurate data could not be provided.

The figures for fixed speed camera infringement notices include data from the following devices: stand alone fixed speed cameras, the speed component of fixed red light/speed cameras and trailer mounted speed cameras.

The figures for Police issued/non-camera speeding offences include hand held, dash mounted and any other non camera detection devices.
