# Summary

- The procurement process for the Digital Wallet and Enabling Platforms has commenced with the release of the forward procurement schedule via QTenders on 18 October 2018.
- Exempt Sch.3(2)(1)(b) Reveal Cabinet consideration
- Channel Nine ran an exclusive news story on the Digital Wallet on 23 October 2018, Which consisted of an interview with Minister Bailey interspersed with additional footage and commentary generated by Channel Nine.
- The Customer-Oriented Registration and Licensing (CORAL) program raised concerns with some of the additional content provided by Channel Nine and its impact on TMR customer reaction to the digital wallet. This was escalated via the Department of Transport and Main Roads' (TMR) media team to Minister Bailey's office.

- In response to the Channel Nine story, Minister Bailey's office has directly engaged with Channel Nine. The CORAL program is actively engaging with the community through TMR's social media team and Customer Services Branch (CSB) call centres to respond to concerns and questions.
- An industry briefing event for the Digital Wallet and Enabling Platforms (DWEP)
  was held on 26 October 2018 with over 90 attendees and 72 suppliers
  represented.
- The request for proposal for DWEP will be released on QTenders on 19 November 2018.

#### Recommendations

- That you note:
  - the progress of DWEP elements of the CORAL program
  - the decision on the location of the regional pilot has not yet been confirmed by Minister Bailey.

# Financial Implications

- An amount of \$\( \begin{align\*} \text{b) Rev} \end{align\*} million has been reallocated from within existing TMR budget allocations for the Digital Wallet pilot.
- Cabinet Budget Review Committee approval will be sought for further funding associated with implementation through the CORAL business case, once the total cost of ownership is understood.

# Background

- The procurement process for the DWEP has commenced, with the release of the forward procurement schedule on 18 October 2018.
- Channel Nine ran an exclusive news story on the Digital Wallet on 23 October 2018. The story consisted of a ministerial interview with Minister Bailey interspersed with additional footage and commentary generated by Channel Nine. The additional footage was not fully supportive of the Digital Wallet and highlighted enforcement concerns and suitability for the entire range of customers.
- The CORAL program had concerns with some of the additional content and its impact on TMRs customers' expectations and reaction to the Digital Wallet. Details of note were:
  - implications around enforcement and additional legal obligations created by a digital licence
  - interviewing only seniors and presenting their reactions for a digital product
  - use of the New South Wales digital wallet in footage.
- An industry briefing event was held on 26 October 2018 to provide interested vendors with contextual information and an overview of the DWEP procurement activity.
- Attendance breakdown and themes from the industry brief are as follows.
  - Registrations totalled 145 (84 attended in person, 61 viewed the video).
    - Representation from 72 different vendors.
  - Questions from vendors indicated they were interested and engaged. Key themes related to the co-design process, timeframes, technical questions including security requirements, and the procurement process.

- With the release of the request for proposal on 19 November 2018, the Digital Wallet project team is:
  - establishing the evaluation panel that will include internal representatives from Transport Regulation Branch, CSB and Information Technology Branch as well as representatives from the Department of Justice and Attorney-General, Queensland Police Service (QPS) and Department of Housing and Public Works
  - establishing the customer groups that will inform the co-design process. These groups represent credential holders, credential users (for example, hoteliers), government partners and special interest groups such as peak bodies supporting domestic violence victims and customers with accessibility requirements
  - engaging a customer experience facilitator to conduct customer research. facilitate vendor/customer workshops and assist in the evaluation of the regional pilot
  - engaging a commercial negotiator to assist during the contracting process
  - developing change and communication strategies to inform actions plans to engage both internal and external stakeholders.

# Issues and Suggested Approach

Exempt Sch.3(2)(1)(b) Reveal Cabinet consideration

- Broader stakeholder engagement in the pilot location is unable to commence until a decision is made on the location of the regional pilot.
- In response to the Channel Nine article, Minister Bailey's office contacted Channel Nine to raise concerns about the additional content. Channel Nine subsequently removed the video and post from social media, however, it remains available in the catch-up full episodes available on their website.
- The CORAL program undertook the following actions in response to the Channel Nine story.
  - Facebook and Twitter posts to address the fact that a procurement activity is in process and it will involve a co-design process with TMR credential holders and user.
    - Direct contact with CSB call centres to alert them of possible questions and to reinforce the message that TMR is entering a procurement process that will actively engage customers and provide avenues for engagement with the CORAL program team.
    - Updated the frequently asked questions for CSC staff to ensure the correct information is shared with customers through the phone or via face-to-face channels.

#### Consultation with Stakeholders

- Early engagement on the Digital Wallet with government and peak bodies has commenced, with the CORAL program team meeting with representatives from:
  - QPS mobile capability unit
  - Royal Automobile Club of Queensland
  - Office of the Information Commissioner.

- The CORAL program is actively engaging with the community through TMR's social media team to respond to concerns and questions from the community.
- The current Facebook statistics in relation to the Digital Wallet include 148 comments, 64 shares, 265 likes and 47 dislikes.
- Themes of the social media comments included:
  - security of the digital wallet
  - whether ownership of the digital wallet is mandatory
  - getting fined if your smart phone is flat or you do not have it with you
  - whether the Digital Wallet would be extended to other licence types, for example, heavy vehicle licences
  - being happy you did not have to carry a physical wallet anymore (having all you need on your phone)
  - how much the digital wallet will cost
  - what happens if you lose your phone.
- The CORAL program has collaborated with the social media team to actively provide responses to comments.



# Background

# **CORAL Program**

The Customer Orientated Registration and Licensing (CORAL) program aims to modernise the registration and licensing system for Queensland by delivering digital and business solutions that simplify and improve the way our customers interact with TMR. It provides the opportunity to reform current business, policy, and regulatory practices as well as modernising our ICT systems. The program aligns with the Queensland Government's priority to be a responsive government and its Digital1st Strategy, delivering an accessible digital service to meet the needs of the community.

# Digital Wallet

The digital wallet – a smart device application that allows you to store electronic credentials and make electronic transactions – will be one of the first deliverables of the program. The digital wallet aligns with our customers' increasing preference for digital services and their desire for convenience in how they transact with government. The digital wallet will provide a better and safer way for Queenslanders to validate their identity by allowing customer to control access to their personal information for commercial and enforcement purposes.

The CORAL program is currently conducting a tender process to partner with supplier/s to develop the digital wallet. The wallet will be codesigned with the community and our partners to ensure a product is developed that is fit for purpose and developed using a human centred design approach.

The CORAL program has identified an opportunity to engage with schools and students to increase uptake and awareness of the Digital Wallet with the local community in the pilot location.

# About the Digital Ambassador program

The Digital Ambassador Program has been designed to create a sense of excitement, build awareness and increase uptake of the Digital Wallet during the codesign and pilot period, and create a network of digital champions within the local community who can test pre-releases, provide feedback and assist members of the pilot cohort to learn to use the digital wallet.

The Digital Ambassador program is proposed to be run in with schools, universities and other education institutes within the Ambassador Program are to:

 Onboard a team of Digital Ambassadors who will act as community advocates to increase community uptake with the Digital Wallet pilot



- Promote video entries via social media and free TMR channels to engage the community and increase Digital Wallet uptake.
- Increase engagement with local schools and community groups within the pilot location

Ambassadors will be identified through a competition in which entrants must submit a video entry, promoting the Digital Wallet and its uses.

# Who are we targeting

The Digital Ambassadors Program will target students aged 15 years and older from local education institutions (for example schools, Universities and TAFE institutes) in the pilot location.

# The competition

Competition entrants will be asked to create a video (maximum length of 2.5 minutes) and upload to a hosting service (for example, Youtube) that showcases:

- Their local region
- Why they can't wait for the Digital Wallet
- Uses for the Digital Wallet
- As an ambassador, how they will help promote it to the community

A prize pool\* will be established to the value of:

- 5x \$1000 value prize for winners, categories may include:
  - Most creative/original
  - Best showcase of the local region
  - Most innovative ideas to promote to the community
  - People's Choice Award (showcased through social media with public voting options)
- \$5000 grant for the overall winner's school or education institution.

(\*Prize pool is indicative and is subject to advice from Legal Services and FinGov).

The competition will be open to students enrolled at schools and education providers in the pilot location. Videos will shortlisted, and finalist videos may be showcased at CSCs, local town halls and pelice stations, as well as touch screen kiosks that the CORAL program may trial.

# Digital Ambassador role

Competition winners will act as Digital Ambassadors for the local community during the Digital Wallet pre-pilot and pilot period. Ambassadors will be signed up to test pre- releases of the Digital Wallet and provide feedback to future functionality. Gift card incentives and sponsored prizes may also form part of the Digital Ambassador package.

Ambassadors will act as the conduit between the community and the CORAL Program, joining the team during local engagement activities such as presence at market stalls, school visits and community centre sessions.

The CORAL Program will coordinate with community policing in the pilot region, to see if other small events like holding learning workshops in community centres with the Digital Ambassadors helping elderly customers understand the Digital Wallet.

Learnings from the program will feed into community change programs in future Digital Wallet pilots and potentially other TMR digital program rollouts in the future.

# Costs

A budget of \$25,000 has been allocated for the Digital Ambassador Program, to include the prize pool, marketing materials, travel costs and a roadshow to participating schools.



# **Background**

 This noting brief is part of a regular series of monthly DG briefs pertaining to the CORAL program.

Prior to any expanded roll-out of the digital wallet, additional funding will be sought
via the Cabinet Budget Review Committee once the total cost of ownership is
better understood through the procurement process.

#### Consultation with Stakeholders

- The CORAL program received your approval (DBN13788) to run a Digital Ambassador Program, designed to engage schools, education institutes and the local community in the Digital Wallet pilot location.
- The CORAL program will commence engagement with the Department of Education in early-2019 in preparation for engagement with schools during the Digital Wallet pilot.
- A Digital Strategy Manager from the Responsive Government team in the
  Department of Housing and Public Works (DHPW) has commenced working with
  the CORAL team two days per week to enable closer cross departmental
  collaboration. The position has been funded by the DHPW and will work with the
  program until early-2019.
- A meeting occurred on 11 December 2018 with Mr Mark Cridland, Deputy Director-General (Policy), DPC. This meeting helped ensure DPC understand the need for the amendments to be in place prior to the Digital Wallet pilot commencing in the sch.3(2)(1)(b) Reveal Cabinet and sought their support to prioritise such amendments in the forward legislative program.
- In December 2018, Mr Chris Goh, General Manager (CORAL) met with officers from the Office of Liquor, Gaming and Racing within DJAG, and with officers from QPS's Road Policing Command to keep them abreast of developments within the CORAL program (and the Digital Wallet more specifically).

- Not Relevant
- The internal and external communication activities following the Honourable Mark Bailey MP, Minister for Transport and Main Roads' announcement, and the Channel 9 story about the digital wallet, indicate a high level of interest and engagement amongst the community.
- The engagement rate of 6.4 per cent for TMR's LinkedIn post was high against business/government engagement benchmark of 1 per cent. On Facebook, the Digital Wallet generated a large volume of comments and shares and a solid engagement rate at 14 per cent. News stories about the digital wallet also appeared on RACQ and ITnews websites, and the Taxi Council Queensland News newsletter.
- The interest in the digital wallet was also reflected amongst TMR staff, as the internal news story was the most viewed article of the week.

# Summary

- The Registration and Licensing Modernisation (R&LM) program board met on 5 July 2018 to discuss the proposal regarding the digital wallet and has supported the inclusion of a digital wallet as part of its program of work.
- The Department of Transport and Main Roads (TMR), as part of its R&LM program, will be developing a one customer view across the 100 plus systems (including TRAILS) that support delivery of registration and licensing services.
- TMR is proposing to introduce a digital wallet that will allow customers to manage transactions with TMR through a unique encrypted identifier that will unify all future customer credentials and provide TMR with a one customer view across its service delivery functions.
- The digital wallet that is being proposed follows on from other jurisdictions including South Australia and New South Wales (NSW). NSW has finalised their trials in Dubbo and have passed legislative changes to allow the statewide roll-out of digital licences. The Federal Government has also allocated \$92.4 million on a new identity management scheme, GovPass to succeed the previous identity framework of MyGov.
- TMR is proposing to pilot a digital wallet, commencing with learner licence and proof of age cards at a regional site in mid-2019. This is yet to be finalised. Initial socialisation has commenced with Queensland Police Service (QPS) and Department of Justice and Attorney-General (DJAG), Department of the Premier and Cabinet (DPC) and Queensland Treasury (QT).
- TMR will investigate the ability to use the existing 'Paywave' and EFTPOS network to validate credentials in the digital wallet to validate the authorities. This might also open the ability for TMR to explore other revenue and loyalty based programs and models.
- TMR is intending to finalise the initiative proposal (IP) via normal governance protocols including to the program board (which has just approved the proposal), Information and Systems Committee and the Executive Leadership Team. At completion of this governance, R&LM can begin a due diligence and market engagement process. These boards are made of key stakeholders across gevernment including DPC, QT, QPS and DJAG.

# **Background**

- Digital wallets are the next evolution of licensing and identity documents which aligns with customers' increasing preference for digital mobile services. The digital wallet concept is already happening with the digitisation of Medicare, banks, concession and retail loyalty cards.
- In Australia, South Australia released a digital wallet in May 2017, which now
  includes a digital driver licence. NSW has been piloting digital licences in Dubbo
  since late-2017. NSW has recently passed legislation to provide for the broader
  roll-out of digital licences and photo ID cards.
- Australia Post has recently developed a Keypass Digital ID, allowing their customers to set up and use a secure digital form of identification.
- The Commonwealth Digital Transformation Agency is developing 'Govpass', a secure digital identity for people to prove who they are when using government services online.
- A number of other jurisdictions have already implemented a digital licence, or have announced their intent to deliver a digital driver licence in the short term. In the United States, Delaware, Idaho, Colorado, Maryland, Louisiana, Washington D.C and Wyoming will all offer digital licences in 2018.
- Estonia has digitised almost all of their government services, including their driver licence. Finland will have a digital licence in place by the end of 2018.
- In March 2016, TMR conducted a closed proof-of-concept with three companies to develop prototypes for a Queensiand digital driver licence.
- Other jurisdictions have focused on delivering a replacement for their existing licences from a physical to digital format. The digital wallet TMR is proposing will also test the ability to allow electronic transactions, unify the customer identity and use the credential as a digital signature to sign electronic forms.

# Issues and Suggested Approach

- A digital wallet will respond to customers' expectations for improved service delivery and convenience by separating customer identity from driving capability. This opens up a range of future service possibilities for the customer. It is also consistent with the government's Digital1st strategy to deliver digital by default. It will also be a critical piece to enable the 'Future State Priorities' of a responsive government.
- However, it is important to recognise that digital identities are still a maturing concept, especially for the end users. Some customers may have concerns around privacy and the unintended use of their details. The digital wallet will put Queenslanders in charge of how they share their credentials, and TMR will be required, as is the current case, to protect customer information against cybercrimes and theft.

#### **Pilot**

- TMR is proposing to conduct a pilot of the digital wallet. During the pilot, it is envisaged that the digital wallet application will be made available to a controlled cohort in a specified geographic area. Initially the pilot would be limited to learner licence and proof of age card holders.
- If the initial pilot is successful, a final business case will be finalised and provided through existing governance processes to approve the broader deployment and expansion to other TMR issued smartcard licence products (a digital wallet).

Exempt Sch.3(2)(1)(b) Reveal Cabinet consideration

- Conducting a pilot, rather than a full roll-out of the digital wallet, will have a lower risk profile as the impacted customers are contained, the communications and change management will be manageable and TMR will have the ability to learn baseline performance and costs from the pilot prior to full implementation. It will also allow TMR to test community and industry acceptance of the digital product as an identity credential and address concerns prior to a statewide release.
- A successful pilot will also help to inform the broader statewide deployment strategy and identify opportunities for functional enhancements.
- Post pilot, and where there is evidence of general customer acceptance of the
  digital wallet platform, TMR will look to expand the authorities and use cases for
  the digital wallet. The digital wallet could potentially include a person's goCard,
  school ID, working with children (blue card), camping permits, fishing licences and
  more.

# **Financial Implications**

- The initial pilot will be funded from within existing budget allocations. However, the
  ongoing costs to maintain a digital wallet are unknown at this time. Costs will likely
  be offset by savings from a reduction in transactions at customer service centres
  and traditional surface mail postage charges. The procurement process will provide
  total cost of ownership certainty prior to committing to a contract and the pilot of a
  digital wallet.
- A final business case will be developed in parallel to the pilot and go through the necessary financial and whole-of-Government assurance gates to gain final endorsement of the investment and agreed benefits.
- Digital licences may resolve some of the limitations associated with physical products such as change of address labels, wear and tear, expiry, processing wait times and production and distribution costs. Payments and renewals of products should be simpler as part of the process.

#### Consultation with Stakeholders

Legislative amendments will be required to support the roll-out of the digital wallet.

The Office of the Information Commissioner will be consulted regarding privacy protections as part of the consultation process.

- Digital credentials might not be acknowledged by other jurisdictions. TMR is
  participating in the development of international digital licence interoperability
  standards and is investigating using the existing standards used for electronic
  transactions by banks to validate credit cards like 'Paywave'. If successful, the
  digital wallet could be used by any jurisdiction to validate its authenticity.
- TMR has met with officers from Liquor Licensing to discuss scanning of digital identities by licensed premises in safe night precincts.
- TMR has also commenced consultations with the Digital Strategy team within the
  Department of Housing and Public Works, Blue Card team within DJAG and
  Department of Agriculture and Fisheries regarding the potential to extend the
  digital wallet to other government issued permits and authorities.
- TMR has previously discussed, and will continue to engage with the Office of the Information Commissioner including the Privacy Commissioner. TMR has also engaged the Queensland Government Chief Information Officer who has also accepted membership on the R&LM Inter-departmental Committee.
- NSW and South Australia are being consulted in relation to lessons learnt from their respective digital licence/wallet projects.
- Consultation will continue to occur with key stakeholders. TMR's customers will be engaged via a co-design process once a vendor is engaged.

# Background

# CORAL Program

The Customer Orientated Registration and Licensing (CORAL) program aims to modernise the registration and licensing system for Queensland by delivering digital and business solutions that simplify and improve the way our customers interact with TMR. It provides the opportunity to reform current business, policy, and regulatory practices as well as modernising our ICT systems. The program aligns with the Queensland Government's priority to be a responsive government and its Digital1st Strategy, delivering an accessible digital service to meet the needs of the community.

# Digital Wallet

The digital wallet – a smart device application that allows you to store electronic credentials and make electronic transactions – will be one of the first deliverables of the program. The digital wallet aligns with our customers' increasing preference for digital services and their desire for convenience in how they transact with government. The digital wallet will provide a better and safer way for Queenslanders to validate their identity by allowing customer to control access to their personal information for commercial and enforcement purposes.

The CORAL program is currently conducting a tender process to partner with supplier/s to develop the digital wallet. The wallet will be codesigned with the community and our partners to ensure a product is developed that is fit for purpose and developed using a human centred design approach.

The CORAL program has identified an opportunity to engage with schools and students to increase uptake and awareness of the Digital Wallet with the local community in the pilot location.

# About the Digital Ambassador program

The Digital Ambassador Program has been designed to create a sense of excitement, build awareness and increase uptake of the Digital Wallet during the codesign and pilot period, and create a network of digital champions within the local community who can test pre-releases, provide feedback and assist members of the pilot cohort to learn to use the digital wallet.

The Digital Ambassador program is proposed to be run in with schools, universities and other education institutes within the Sch.3(2)(1)(b) Reveal Cabinet The objectives of the Digital Ambassador Program are to:

 Onboard a team of Digital Ambassadors who will act as community advocates to increase community uptake with the Digital Wallet pilot



- Promote video entries via social media and free TMR channels to engage the community and increase Digital Wallet uptake.
- Increase engagement with local schools and community groups within the pilot location

Ambassadors will be identified through a competition in which entrants must submit a video entry, promoting the Digital Wallet and its uses.

# Who are we targeting

The Digital Ambassadors Program will target students aged 15 years and older from local education institutions (for example schools, Universities and TAFE institutes) in the pilot location.

# The competition

Competition entrants will be asked to create a video (maximum length of 2.5 minutes) and upload to a hosting service (for example, Youtube) that showcases:

- Their local region
- Why they can't wait for the Digital Wallet
- Uses for the Digital Wallet
- As an ambassador, how they will help promote it to the community

A prize pool\* will be established to the value of:

- 5x \$1000 value prize for winners, categories may include:
  - Most creative/original
  - Best showcase of the local region
  - Most innovative ideas to promote to the community
  - People's Choice Award (showcased through social media with public voting options)
  - \$5000 grant for the overall winner's school or education institution.

(\*Prize pool is indicative and is subject to advice from Legal Services and FinGov).

The competition will be open to students enrolled at schools and education providers in the pilot location. Videos will shortlisted, and finalist videos may be showcased at CSCs, local town halls and pelice stations, as well as touch screen kiosks that the CORAL program may trial.

# Digital Ambassador role

Competition winners will act as Digital Ambassadors for the local community during the Digital Wallet pre-pilot and pilot period. Ambassadors will be signed up to test pre- releases of the Digital Wallet and provide feedback to future functionality. Gift card incentives and sponsored prizes may also form part of the Digital Ambassador package.

Ambassadors will act as the conduit between the community and the CORAL Program, joining the team during local engagement activities such as presence at market stalls, school visits and community centre sessions.

The CORAL Program will coordinate with community policing in the pilot region, to see if other small events like holding learning workshops in community centres with the Digital Ambassadors helping elderly customers understand the Digital Wallet.

Learnings from the program will feed into community change programs in future Digital Wallet pilots and potentially other TMR digital program rollouts in the future.

# Costs

A budget of \$25,000 has been allocated for the Digital Ambassador Program, to include the prize pool, marketing materials, travel costs and a roadshow to participating schools.

# Issues and Suggested Approach

- TMR has no issue with the Australian Government's intention to provide a summary of data and digital transformation initiatives nationally. Specifically, the information in relation to the digital wallet is limited and is currently available on the TMR website.
- The draft information the Australian Government has provided also briefly mentions
  the enabling platforms component Queensland is procuring as commencing in late
  2019. TMR has requested that the Australian Government remove any reference to
  the enabling platforms component at this time, as the procurement relates to a
  proof of concept only.

## Summary

- On 29 October 2018, the Department of Transport and Main Roads (TMR)
  received correspondence from the Queensland Government Chief Information
  Office (QGCIO) for agencies interested in submitting a Proof of Concept (PoC) for
  funding with the federal Digital Transformation Agency (DTA).
- The opportunity leverages the aligned objectives of the DTA's Digital Identity Program (GovPass) and the Customer Oriented Registration and Licensing (CORAL) Program, and potentially extends the application and usability of the TMR's Digital Wallet across federal and state government services.
- DTA has since evaluated TMR's submission and is putting forward a request as
  part of its business case submission to the federal Treasury to support the funding
  bid. The outcome of this submission will not be known until May 2019.

# Issues and Suggested Approach

- On 14 September 2018, the Australian Digital Council (the Council), consisting of Ministers from across Australia with responsibility for public data and digital transformation, agreed to prioritise work on improving experiences for people and businesses through cross-jurisdictional collaboration on digital identity projects.
- DTA's GovPass aims to give Australian citizens and permanent residents a single and secure way to create a digital identity which can be used to access online government services.
- The GovPass will focus on delivering a secure digital identity which protects the privacy of those who use it. This will be achieved through a set of security standards, a network of digital identity providers including myGovID, an identity gateway to connect government service providers and digital identity providers, and provision of digital services that rely on a digital identity to confirm someone is authorised to access their service.
- DTA called for states and territories to submit funding proposals to run PoCs that advance the objectives of the Federal Government and GovPass. TMR submitted a PoC proposal of \$1.2 million for consideration as part of DTA's 2019–20 budget proposal.

- TMR's PoC proposes to use the Digital Wallet trial to test integration with the GovPass. In particular, TMR will have access to an authoritative business identity which is currently only available through the Federal Government. This will substantially improve TMR's ability to securely authenticate and authorise transactions of businesses within Queensland.
- If the PoC is successful, the proposed federated nature of the Digital Wailet could also have substantial benefits for whole-of-Government, citizens and businesses in how they transact nationally.
- Note that TMR is aware the Department of Housing and Public Works (DHPW) has submitted a separate proposal. Its scope is to support GovPass through the existing Identity Management Platform created by One Stop Shop.
- DHPW has been informed through both QGCIO and Responsive Government of TMR's proposal.

# Financial Implications

 At this stage there are no implications. The funding sought from DTA by TMR would be sufficient to test the GovPass sharing capability with the Digital Wallet and prepare TMR for a potential live pilot.

# Summary

- Mr Christopher Goh, General Manager of Customer Oriented Registration and Licencing (CORAL) was nominated to represent Australia in the development of an International Standard for a Mobile/Digital Driver Licence Application (ISO/IEC CD 18013 part 5).
- The International Standards Organisation (ISO) committee held a ballot on new changes in Leiden, Netherlands, between 4 and 6 February 2019. Mr Goh's trip was funded by Austroads and approved by the Honourable Mark Bailey MP, Minister of Transport and Main Roads.
- The members of the committee included vendors Google, Apple, Samsung, Toshiba, Panasonic, Idemia, and Gemalto, as well as jurisdictional driver licensing regulators. Countries represented included France, Netherlands, Portugal, United States of America, Germany, Finland, Austria, South Korea, Japan and South Africa.
- Several vendors, including Apple and Google, intend to embed the data schemas
  for the proposed standard into the 'firmware' code of mobile devices within the next
  12 months. The implications mean that mobile and tablet devices worldwide may
  soon have the capability to verify identities globally from issuing authorities of driver
  licences and passports.

# Financial Implications

## Background

- Mr Goh was nominated by you, as Director-General of the Department of Transport and Main Roads (TMR), to represent Austroads on the ISO/IEC JTC1/SC17/WG10 working group. The working group is tasked with developing a new Part 5 to ISO/IEC 18013 to standardise mobile/digital driver licence applications.
- The existing committee is largely industry led and each country has been allocated one voting position on the committee.
- The ISO will set critical standards in how digital licences share and manage:
  - biometric data, including fingerprints and images
  - authentication and verification of the holder's identity
  - encryption, privacy and securing the exchange of information
  - operating in an offline capacity when mobile devices cannot connect
  - validating authenticity of other jurisdictional identity
  - governance, compliance and auditability of the standard.
- Austroads has established a Digital Driver Licence Interoperability Working Group, comprising representatives from Queensland, Victoria, New South Wales, South Australia and Western Australia. Mr Goh has had discussions with this Interoperability Working Group in relation to the draft standard. This is to help ensure that any issues or concerns from Australian jurisdictions are properly understood and a consolidated position can be presented to the ISO committee. It was agreed to continue to leverage the existing Austroads Interoperability Working Group (AIWG) as the governing body to oversight Australia's involvement in the development of the ISO.

#### Key Issues

- The ISO for mobile/digital licences has implications for Queensland and other jurisdictions who have implemented, or are considering implementing, digital licences. Members of the ISO have committed to implementing the standard in their future systems. It is also important that any interoperability protocol developed by Austroads is consistent with the international standard, so that Australians travelling abroad can use their digital licence.
- Apple and Google, with their mobile operating systems, comprise more than 99 per cent of the mobile operating system market. As members of the ISO, they have indicated that they are intending to embed the standards in all future releases of their operating systems (Android and IOS).
- The immediate implication for issuing authorities that intend to develop a digital driver licence, including Queensland, is that if they want their credentials to operate seamlessly, adopting the standards will be critical. Moreover, the ability to influence how these organisations build critical safeguards in privacy, security and interoperability in their systems requires regulators to be engaged in the development of the ISO.
- Long-term risks for government agencies are that these organisations have realised how government identities are critical to furthering their business and operating models. With Google and Apple able to aggregate the identities of citizens from across the world, new strategic and policy discussions are required on how to ensure citizen identities are not compromised.
- While Google and Apple have its own authentication platforms, they are not able to get irrefutable evidence of a person's identity. A person can hold multiple Google and Apple accounts. And although they can use digital 'foot prints' to validate a person's identity, they realise much of this validation is already done by government issuing authorities.
- However, not all government identity enrolment frameworks are equally robust. As such, a governance process will need to be established to determine which digital identities should be trusted. Austroads would likely play a role in this process.
- Queensland will continue to work with technical and policy experts in jurisdictions, to ensure the ISO safeguards personal identity, while balancing the need to provide seamless services across mobile platforms.
- Mr Goh has been asked to work specifically on critical security and privacy safeguards and will be seeking feedback on the existing draft framework from the AIWG.
- The AIWG has indicated they would like a further showcase on the implications of the ISO to understand the impact on existing privacy and regulatory policy regimes.
   This will be provided in the coming weeks.
- An agenda item at the March 2019 Austroads Registration and Licensing Taskforce meeting will also consider this issue.
- The ISO/IEC JTC1/SC17/WG10 working group hope to publish Part 5 of ISO/IEC 18043 in mid–2019. This will deal with 'day one' use cases. Immediately post publication of the standard, the working group will revise the standard to address more complex 'day two' use cases, such as online transactions using the mobile/digital licence as an identification credential.

## Financial Implications

 There are further international travel commitments required to maintain Mr Goh as the Australian representative on the ISO/IEC JTC1/SC17/WG10 working group to develop Part 5 of ISO/IEC 18013 to standardise Mobile/Digital Driver Licence Applications. These costs are estimated to be approximately \$16K per year.


