QUESTION:

With reference to the Centenary Bridge duplication project-

Will the Minister advise (a) the reasons why major construction did not start in 2021 as per the Government's commitment prior to the last state election and (b) the current expected major construction start date?

ANSWER:

I thank the Member for Broadwater for the question.

The Queensland Government has committed \$20 million for planning and design, and \$112 million for construction of a new three-lane northbound bridge over the Brisbane River at Jindalee, refurbishment of the existing Centenary Bridge to create a three-lane southbound bridge and improved active transport facilities for the river crossing.

The Australian Government has committed \$112 million for construction, making the total committed funding \$244 million.

The final stage of the tender process closed on 26 October 2021, with the tender evaluation in progress. The construction contract was expected to be awarded in late 2021, with construction to start in 2022. Award of the construction contract has been delayed due to the complexities surrounding the assessment of two unusually low bids and two competitive alternative tenders.

Investigation of the alternative tenders required additional time for due diligence assessment, and this adversely impacted on the project commitments, with delays to the previously announced start of construction date.

The anticipated contract award for the construction of the Centenary Bridge upgrade is late 2022, subject to progress of a complex tender negotiations and assessment. Once the construction contract has been awarded, the Department of Transport and Main Roads (TMR) will provide an update to the community.

The Palaszczuk Government is delivering its seventh record transport and roads infrastructure program in a row, as detailed in the *Queensland Transport and Roads Investment Program 2022–23 to 2025–26*, which outlines \$29.7 billion in investment over the next four years and is estimated to support an average of 25,200 direct jobs over the life of the program. Of this, \$3.858 million is committed across TMR's Metropolitan Region, estimated to support an average of 3280 direct jobs over the life of the program.

Summary

- In 2019, the Department of Transport and Main Roads (TMR) completed a planning study for the Centenary Motorway upgrade. This planning study identified possible staged upgrades along the Centenary Motorway from Sumners Road, Darra, to Frederick Street, Toowong.
- The Centenary Bridge is the first stage to progress from the planning study. • Community consultation on the design was held between 19 August and 19 September 2021.
- Construction was expected to commence in early 2022. However, the award of the • construction contract has been delayed due to the complexities involved in the tender assessment process.
- There has not been a community update on the project since August 2021. This community update will include outcomes from the consultation, an updated project map and updated milestones for the project.

Recommendations

- That you approve:
 - the updated Centenary Bridge upgrade project map (Attachment 1) be uploaded to the project webpage
 - the Centenary Bridge consultation summary report (Attachment 2) be uploaded to the project webpage and emailed to local elected representatives, stakeholders and the project database.

Financial Implications

There are no financial implications associated with the above recommendation.

Background

The Queensland Government has committed \$112 million for construction of a new three-lane northbound Centenary Bridge over the Brisbane River at Jindalee, refurbishment of the existing bridges, and improved active transport facilities for the river crossing and \$20 million for design and planning.

The Australian Government has committed \$112 million, making the total construction funding \$224 million and total project funding \$244 million.

- It is the first major project to apply TMR's new key result areas (KRAs) and performance measures aimed at advancing the government's priorities to deliver improved social, economic and environmental outcomes for Queenslanders. The KRAs include a set of Best Practice Industry Conditions for Transport Civil Projects (the Transport BPIC).
- Stage 2 of the tender process closed on 26 October 2021, with the tender evaluation currently in progress.
- The construction contract was expected to be awarded in late 2021. However, the award of the construction contract has been delayed due to the complexities involved in the tender assessment process.
- The Centenary Bridge provides a critical link in Brisbane's strategic transport network and is vulnerable to severe performance impacts and congestion in the event of a traffic incident or similar network disruption.
- The Centenary Bridge upgrade is expected to reduce the frequency and severity of crashes, while increasing efficiency and travel time reliability between Brisbane's western suburbs, local destinations and the central business district.

Key Issues

- Community consultation for the Centenary Bridge upgrade project was held between 19 August and 19 September 2021 (Attachment 3 -- COM909).
- Community consultation generated 232 pieces of feedback, which represented 201 individual stakeholders (some stakeholders submitted multiple pieces of formal feedback) (Attachment 2).
- Based on all respondents (201 individuals):
 - fifty-six per cent (113 individuais) provided mixed comments and wanted the project to progress however, would prefer to see a larger scale project occur rather than the project as it was presented during consultation
 - twenty-nine per cent (59 individuals) did not support the project in its current form
 - ten per cent (20 individuals) were neutral
 - five per cent (nine individuals) provided positive comments on the project as it was presented.
- Given the disruption to face-to-face sessions due to the COVID-19 pandemic restrictions, the project team continued to collate feedback throughout the remainder of September and October 2021, including any additional incoming submission up to, and including, 20 October 2021.
- Due to complexities surrounding the tender process, there has been no community update on the project since August 2021.
- There have been updates to the bridge design since this time, and the project map has been updated accordingly and will be updated on the webpage and in the consultation report (**Attachment 1**). The changes include the active transport alignment exiting the bridge into Amazon Place park and the intersection at Sinnamon Road adjacent to the entry ramp (northbound).
 - Award of the construction contract has been delayed due to the complexities surrounding the assessment of two unusually low bids and two alternative tenders.
- The final stage of the procurement process has commenced with the highest ranked tenderer. Interactive meetings with the preferred tenderer to work through the commitments against the KRAs including the Transport BPIC have been held, with the process expected to conclude shortly.

- Project milestones indicated construction award was expected to be announced in December 2021 and construction scheduled to commence in 2022. The currently published newsletter from August 2021 will be removed from the project webpage (Attachment 4).
- Principal contractor main-line construction activities are now expected to commence in 2023. Enabling works, including geotechnical investigation and asphalt deck protection works, are completed.

Financial Implications

- Funding of \$224 million from the Australian and Queensland governments, on a 50:50 basis, has been secured for construction.
- Funding of \$20 million from the Queensland Government was committed for design and planning.
- The tender assessment is currently being finalised and the project team has confirmed that additional funding is required.
- Communication and engagement activities will be budgeted under the project's allocation.

Employment

 This project is estimated to support an average of 240 direct jobs over the life of the project.

Media

- There has been an increase in media coverage in recent months around the Centenary Motorway corridor requests for improvements to noise barriers and inclusion of bus lanes/public transport on the motorway and on the frequency of traffic incidents on the Centenary Bridge.
- It is expected that as the original timeline for construction extends, there will be an increase in media interest around the start of construction, the cost impacts and future stages of the motorway upgrade.
- TMR has already seen an increase in stakeholder enquiry regarding the start of construction timeline.

Election Commitments

- The Centenary Bridge Upgrade Project relates to two Queensland Government election commitments:
 - GEC808 (2017) for the business case
 - GEC1676 (2020) for construction.

Government Objectives

Project overview

The Centenary Bridge Upgrade in Jindalee proposes a new three-lane northbound bridge, rehabilitation of the existing bridges to three lanes southbound, plus opportunities for improved active transport.

This extra capacity will provide greater efficiency and travel-time reliability between Brisbane's CBD and the western suburbs, between local destinations, and along the entire Centenary Motorway.

The planning study for the Centenary Motorway Upgrade identified possible staged upgrades along the Centenary Motorway from Sumners Road, Darra, to Frederick Street, Toowong. These staged upgrades along the region's future transport needs and include options focused on safety, improving travel-time reliability, and new active transport opportunities for pedestrians and people who ride bikes.

The Centenary Bridge is the first stage to progress from the planning study and carries more than 85,000 vehicles a day. Current traffic modelling shows that by 2036, around 152,000 vehicles per day will want to cross the bridge.

The upgrade offers the following benefits:

- improved safety to reduce the frequency and severity of crashes on the Centenary Bridge
- increased capacity to improve travel-time reliability and cater for current and future traffic needs
- improved active transport facilities
- longer and safer merge lanes for entry and exit ramps.

Main construction activities are expected to commence in 2023.

Community participation

The community consultation period opened 19 August 2021 and closed 19 September 2021. Health directives to prevent the spread of COVID-19 meant that planned community information sessions and face-to-face meetings could not be held.

Given the disruption to face-to-face sessions, the project team continued to collate feedback throughout the remainder of September and October 2021, including any additional incoming submission up to and including 20 October 2021 in this analysis.

Community feedback was received through emails, phone calls, at meetings, via elected representatives offices and letters.



Consultation feedback summary

The project team received 232 pieces of feedback during the consultation period from 201 unique stakeholders. Some stakeholders emailed, called or contacted local Electorate Offices and TMR to submit multiple pieces of feedback.

Nine stakeholders fully supported the project, 59 did not support it, 113 stakeholders were happy the project was going ahead but would have preferred a larger scope to include upgrading the motorway as well, while 20 remained neutral.

The concerns and issues raised, and questions asked were reflected in the written feedback with the most frequently mentioned topics:

- Needs to include more not literally just the bridge.
- The whole Centenary Motorway needs upgrading what is the plan if this is stage 1?
- This does not help congestion at all.
- You are simply moving the bottleneck across the river waste of money vs advertised benefit.
- Construction impacts on the local community why can't the project include more, not just the bridge?
- Public transport why are we not looking at light rail, bus lanes, additional city cats/ferries. Less cars on the road (including why not use the Kenmore Bypass land for light rail/active transport corridor).
- Active transport needs to address more than just the bridge.
- Noise barriers why are these not included?

As a result of additional questions being asked during consultation, the frequently asked questions document has been updated, published on the project webpage and shared with participants.

Next steps

The project team has considered the feedback provided through the consultation. Responses to this feedback have been included in the frequently asked questions section on the web page and has been shared with consultation participants.

Construction timings and impacts will be determined once a construction contract has been awarded. TMR will continue to work closely with key stakeholders, including impacted local businesses, residents and community interest groups as the project progresses.

- In line with the October 2020 Cabinet Budget Review Committee decision, the Centenary Bridge upgrade is the first major project to apply TMR's new key result areas (KRAs) aimed at advancing government's objectives to deliver improved social, economic and environmental outcomes for Queenslanders. The KRAs include a set of Best Practice Industry Conditions for Transport Civil Projects (the Transport BPIC).
- TMR has extensively consulted with industry stakeholders on the application and implementation of the KRAs, including the Transport BPIC, particularly in regard to procurement and delivery of this project.
- Contract for construction is expected to be awarded in late 2021 and construction to commence in 2022.

Key Issues

- The overall project plan (Attachment 7) will be updated once discussions have been finalised with Brisbane City Council (BCC) on the alignment of the active transport path through Jindalee skate park. Discussions around reducing the number of trees to be removed from the park may change the final alignment.
- Local media, businesses, schools and residents may be critical of any proposed changes, suffering from construction fatigue, advocating for the work to be completed faster, and questioning when future stages will be funded and constructed.
- Commercial businesses and residents in the immediate project area will be impacted by construction and will require careful management with contractors.
- Realignment of entry or exit ramps may cause concern for businesses and residents.
- Disruption to shared pathways will directly impact residents and commuters using the Centenary bikeway.
- BCC's local road network and active transport may be impacted by construction activities.
- Some community facilities may be affected, causing wider community concern.
- Environmental impacts due to being adjacent to the Brisbane river and the Jindalee Greek Catchment area will require consultation with various environmental groups and an understanding of approvals required for removal, impact or replacement of flora.
- There are several trees that will be required to be removed as part of the construction of the bridge and associated active transport connections and upgrades.
- Due to the works being based predominantly on or adjacent to the Centenary Motorway, night works are inevitable and the proximity to residents may cause increased noise complaints.
- The community engagement intends to:

provide clear, comprehensive and timely information to stakeholders and the community about potential impacts and future timeframes, while managing expectations about construction and delivery timing

incorporate stakeholder feedback to inform the construction stage of the Centenary Bridge upgrade.

Financial implications

 Funding of \$224 million on a 50:50 basis from the Australian and Queensland governments has been secured for construction.

These include briefings with Ms Jessica Pugh MP, Member for Mount Ommaney, Mr Milton Dick MP, Member for Oxley; local councillor for Jamboree Ward; followed by Mr Michael Berkman MP, Member for Maiwar; Dr Christian Rowan MP, Member for Moggill; Mr Julian Simmonds MP, Member for Ryan and local councillors for Walter Taylor and Pullenvale Wards.
- Community information sessions are planned for August 2021 within the local area using the key messages and visuals in the attachments to notify the community of times and locations.
- These information sessions will help inform the community of the scope and benefits of the project, when construction will begin, potential construction impacts and active transport provisions.
- Local community groups and interest groups, including bicycle user groups, will be offered briefings on the project.

- On 3 June 2021, representatives from the Department of Transport and Marr Roads (TMR) met with Ms Jess Pugh MP, Member for Mount Ommaney.
- The purpose of the meeting was to update Ms Pugh on the expression of interest (EOI)
 process for the construction tender of the Centenary Bridge upgrade
- At this meeting Ms Pugh asked the following questions, which TMR took on notice.
 - Noise barriers: a direct request for noise barriers to be included in the scope for works for residents along the Jindalee Creek (Kooringal Drive, Jindalee) – is this in scope of the project?
 - A detailed road traffic noise assessment has been completed in accordance with TMR's Transport Noise Management. Code of Practice – November 2013 (the code). The code provides guidelines for assessing and managing road traffic noise and determining the requirements, if any, for possible noise-reducing treatments.
 - The current design does not include the installation of noise barriers at this location, as there are no exceedances predicted beyond the threshold noise levels.
 - Traffic lights on Sinnamon Road, Jindalee: a request to investigate smart lights that look to co-ordinate with traffic flows and ensure maximum efficiency – is this in scope of the project?
 - Changes to the traffic lights at this location are outside the scope of the Centenary Bridge upgrade project however, may be considered in future TMR works or projects.
 - 3. Ramp metering: a request to investigate if ramp metering on the Jindalee side of the project heading northbound is feasible – is this in scope of the project?
 - As part of the bridge upgrade project, the Sinnamon Road entry ramp and merging lanes will be extended to improve safety.
 - Ramp metering is not included as part of the upgrade. However, maybe considered in future TMR works or projects.

Centenary Bridge Upgrade Project snapshot – July 2021

The announcement in October 2020 of a further \$224 million funding for the Centenary Bridge Upgrade in Jindalee will enable the construction of a new three-lane northbound bridge and refurbishment of the existing bridge to become a three-lane southbound bridge with improved active transport provisions. This will increase capacity, efficiency and travel-time reliability along the whole Centenary Motorway as well as the routes between Brisbane's western suburbs, other local destinations and the Brisbane C8D. It will also deliver better community and road user outcomes and provide improved facilities for active transport users.

Situation

The Centenary Bridge Upgrade is the first stage to progress from the Department of Transport and Main Roads' (TMR's) planning study for the Centenary Motorway Upgrade from Sumners Road, Darra to Frederick Street, Toowong.

The planning study investigated the option of providing six lanes on the existing alignment of the Centenary Motorway.

The Centenary Bridge provides a critical link as the only Brisbane River crossing upstream of the Captain Cook Bridge (Riverside Expressway) that can serve intra-andinter-regional traffic.

Consequently, Brisbane's strategic transport network is vulnerable to severe delays and congestion in the event of traffic incidents or network disruptions.

More than 85,000 vehicles a day cross the Centenary Bridge and current traffic modelling indicates by 2036, 152,000 vehicles a day will want to cross the bridge.

Solution

In November 2017, the Queensland Government committed \$4 million to complete the business case for the Centenary Bridge Upgrade. In June 2018, it allocated a further \$16 million to fast-track the significant geotechnical, hydraulic and technical investigations required to complete the design of the bridge. Detailed design is now complete and the project is fully funded following the October 2020 announcement by the Australian and Queensland governments of \$224 million construction funding on a 50:50 basis.

Benefits

The Centenary Bridge Upgrade will help increase capacity, efficiency and travel-time reliability along the whole Centenary Motorway, as well as the routes between Brisbane's western suburbs, other local destinations and the Brisbane CBD. Overview

The Department of Transport and Main Roads (TMR) is constructing a new three-lane northbound bridge and refurbishing the existing bridge to become a three-lane southbound bridge at Jindalee.

The Queensland Government committed \$20 million for planning and design (now complete), and a further \$112 million for construction. The Australian Government has also committed \$112 million, making the total committed funding \$244 million.

This extra capacity will provide greater efficiency and travel-time reliability between Brisbane's CBD and the western suburbs, between local destinations, and along the entire Centenary Motorway.

The Centenary Bridge carries more than 85,000 vehicles a day and current traffic modelling shows that by 2036, around 152,000 vehicles per day will want to cross the bridge. The Centenary Bridge Upgrade has been identified as stage 1 of the Centenary Motorway Upgrade.

- A new three-lane northbour o bridge
- Remediation of the existing bridges to create three southbound lanes

QUESTION:

Will the Minister guarantee that the Centenary Bridge duplication will be delivered within the project budget of \$244m?

ANSWER:

I thank the Member for Broadwater for the question.

As with any infrastructure project, there are a number of social, economic, and environmental factors that can influence both cost and construction timelines. The \$244 million in funding, which is jointly committed by the Queensland and Australian governments, has been allocated to the project based on extensive planning, detailed design, and an understanding of the market at a point in time. Currently, the Centenary Bridge duplication is in the tender phase and the budgetary requirements can be only finalised once the tendering process is complete.

The Palaszczuk Government is delivering its sixth record transport and roads infrastructure program in a row, outlining \$27.5 billion in investment over the next four years and estimated to support an average of 24,000 direct jobs over the life of the program. Of this, \$3.371 billion is committed across the Department of Transport and Main Roads' Metropolitan Region, which is estimated to support an average of 2930 direct jobs over the life of the program

Queensland's world-leading pandemic response has made it the place to be and, to support the State's population boom, significant road upgrades are being delivered as part of *Queensland's COVID-19 Economic Recovery Plan*. With the Brisbane 2032 Olympics and Paralympics on the horizon, these upgrades provide immediate economic benefits, support more jobs, and deliver ongoing benefits of vital infrastructure for years to come.
