# 1 INTRODUCTION

# 1.1 Specification Suite

This Specification applies to the general requirements of landscape and revegetation works for road construction and associated works. It provides the general requirements to the five Specifications that are known collectively as the landscape and revegetation Specification suite.

The Specification shall also be read in conjunction with Specifications MRS01 *Introduction to Specifications* and Technical Standards and other Specifications as appropriate.

The Specification suite forms part of the Main Roads Specifications and Technical Standards.

# 1.2 Specification Reference Documents

The Main Roads Landscape and Revegetation User Guidelines provide guidance for many aspects of landscape and revegetation. The user guidelines are provided as a guide only for the Contractor. The Contractor is responsible for achieving the outcomes stated in the Specification.

## 2 MEASUREMENT OF WORK

# 2.1 Work Operations

Work operations for all items of work listed in the landscape and revegetation Specification suite shall include operations listed in Clause 2.1.5 of MRS01 *Introduction to Specifications*.
