RECYCLED MATERIALS FOR PAVEMENTS

1 INTRODUCTION

This specification applies to the material requirements for recycled materials to be used in pavements for road construction, rehabilitation and maintenance.

This specification consists of Clauses 1 and 2 of this MRS35 and all Clauses of MRTS35.

This specification shall be read in conjunction with Standard Specifications MRS01 Introduction to Specifications, MRS50 Specific Quality System Requirements and other Standard Specifications as appropriate.

This specification forms part of the Main Roads Specifications and Technical Standards Manual.

2 MEASUREMENT OF WORK

2.1 Standard Work Items

In accordance with the provisions of Clause 2 of MRS01 *Introduction to Specifications*, the standard work items covered by this Specification are listed in Table 2.1.

2.2 Work Operations

Item 4151R Unbound pavement, Recycled Material Blend Type RM001, [*layer location in pavement*]. Item 4152R Unbound pavement, Recycled Material Blend Type RM002, [*layer location in pavement*]. Item 4153R Unbound pavement, Recycled Material Blend Type RM003, [*layer location in pavement*]. Item 4154R Unbound pavement, Recycled Material Blend Type RM004, [*layer location in pavement*]. Item 4155R Unbound pavement, Recycled Material Blend Type RM005, [*layer location in pavement*]. Work Operations incorporated in the above items include –

- a) Work Operations listed in Clause 2.1.5 of MRS01 Introduction to Specifications;
- b) Winning/reclaiming and processing of feed materials to produce uniform and homogenous product materials;
- c) Stockpiling;
- d) Supply and delivery of all material to the pavement;



- e) Spreading of material over the pavement in a way that ensures that there is no segregation of material;
- f) Supply and incorporation of water;
- g) Compacting and trimming;
- h) Additional work to achieve higher tolerances;
- i) Maintenance of the subgrade and/or pavement courses; and
- j) Testing including compliance testing and testing for reporting only.

Item 4156R New material to replace material not suitable for stabilisation, Recycled Material Blend Type RM006.

Item 4157R New material to replace material not suitable for stabilisation, Recycled Material Blend Type RM007.

Work Operations incorporated in the above items include -

- a) Work Operations listed in Clause 2.1.5 of MRS01 Introduction to Specifications;
- b) Winning/reclaiming and processing of feed materials to produce uniform and homogenous product materials;
- c) Stockpiling;
- d) Supply and delivery of all materials to the pavement;
- e) Spreading of material over the pavement in a way that ensures that there is no segregation of material;
- f) Compacting and trimming the materials to facilitate in situ stabilisation and work operations related to it;
- g) Maintenance of the subgrade; and
- h) Testing including compliance testing and testing for reporting only.

2.3 Basis of Payment

Payment is based on finished compacted volume in the pavement.
