About this document

Austroads' <u>Guide to Traffic Management</u> Part 12: Integrated Transport Assessments for Developments is concerned with identifying and managing the impacts on the road system arising from land use developments. It provides guidance for planners and engineers associated with the design, development and management of a variety of land use developments. The Guide aims to ensure consistency in the assessment and treatment of traffic impacts, including addressing the needs of all road users and the effect upon the broader community.

Part 12 presents the land use and transport planning context for traffic impact assessment, including travel demand, safety, parking and access management issues. It provides guidance on the need and criteria for impact assessments, and a detailed procedure for identifying and assessing the traffic impacts and mitigating their effects. Assessment of safety, infrastructure and environmental effects is also covered. Examples are given of checklists, report structures, traffic generation rates and case study projects.

How to use this document

The Department of Transport and Main Roads has agreed to adopt the standards published in Austroads *Guides* as part of national harmonisation. The department seeks to avoid duplicating information addressed in national guidance and has developed documents instead that provide Queensland-specific advice while following the structure established in Austroads *Guides*.

Queensland-specific advice includes practices which vary from national practice because of local environmental conditions (such as geography, soil types, climate); different funding practices; local research; local legislation requirements; and to expand instruction on particular issues.

As such, this Part of the *Queensland Guide to Traffic Management* takes precedence over the Austroads *Guide to Traffic Management* Part 12: *Integrated Transport Assessments for Developments* except where the *Guide* is accepted without changes.

This Part is designed to be read and applied together with Austroads *Guide to Traffic Management* Part 12: *Integrated Transport Assessments for Developments*. Readers must have access to the Austroads *Guide* to understand application in Queensland.

This document:

- sets out how the Austroads *Guide to Traffic Management* Part 12: *Integrated Transport* Assessments for Developments applies in Queensland
- has precedence over the Austroads *Guide to Traffic Management* Part 12: *Integrated Transport Assessments for Developments* when applied in Queensland, and
- has the same section numbering and headings as the Austroads *Guide to Traffic Management* Part 12: *Integrated Transport Assessments for Developments*.

	Similarly, references may be made to other Austroads Guides (for example, when reading AGTM Part 12, the reader may be referred to the <i>Guide to Road Safety</i> Part 3: <i>Speed Limits and Speed Management</i>).
	In such cases, the reader must refer to the equivalent Queensland Guide first, where such exists. Check the applicability of the equivalent Queensland Guide before referring to the referenced Austroads Guide Part.
