Recreational marine licence census June 2013

About This Publication

This publication presents the results of a census taken of the number of current Queensland recreational marine licences on 30 June 2013. The data presented in this publication was extracted from the Department of Transport and Main Roads TRAILS Registration System (the register) on 1 July 2013.

In Queensland, being issued a *Recreational Marine Driver Licence* (RMDL) is a necessary prerequisite to being issued with a *Personal Watercraft Licence* (PWCL).

These two marine licences are issued in perpetuity and so will remain current unless they are surrendered, cancelled or until the effluxion of time assures the licence can no longer be in use.

The tables provide the number of extant recreational marine licences classified by type, maritime region, the age and gender of the licensees and whether or not a licensee was the registrant of a recreational vessel.

Key Findings

On June 30 2013 there were 761,321 licensees who had been issued with a then current recreational marine licence. Eighty-five per cent of these licensees have been issued with a RMDL while the remaining 15% have been issued with both a RMDL and a PWCL.

Seventy-six per cent (576,614) of these licensees were not, at the time of this census, the registrant of any recreational vessels.

Of the 646,848 licensees who only hold a RMDL, 24% (152,667) were the registrants of 173,021 boats (that is recreational vessels other than PWC) which account for 76% of all then registered boats.

Of the 114,122 holders of both a RMDL and a PWCL, 17% (19,885) were the registrants of 23,044 recreational boats while 13% (14,888) were the registrants of 16,335 PWC. These boats account for 10% of all the then registered boats while these PWC account for 87% of all the then registered PWC.

Eighty-eight per cent of those licensees who were the registrant of at least one boat and no PWC have a single

boat. Likewise 93% of those licensees who were the registrant of at least one PWC and no boats have a single PWC.

Less than half of one per cent (3,483) of licensees were the registrant of at least one boat and at least one PWC. The majority (2495) of these licensees were the registrant of a single boat and a single PWC.

The proportion of RMDL holders who were the registrant of a boat increased from 20% at the time the licence was issued, to 26% after 30 years and then fell to 12% among those who have held a RMDL for 50 years or more.

The proportion of PWCL holders who were the registrant of a PWC increased from 16% at the time the licence is issued, to 18% after one year and then fell to 11% among those who have held a PWCL for 8 years.

The Brisbane maritime region accommodated the majority of RMDL (63%) and PWCL (76%) holders while the Mackay region accommodated the smallest proportion of RMDL (6%) and PWCL (4%) holders.

RMDL holders were most likely in the Mackay region (31%) and least likely in the Brisbane maritime region (20%) to be the registrant of a boat.

PWCL holders were most likely in the Mackay maritime region (15%) and least likely in the Cairns maritime region (13%) to be the registrant of a PWC.

Sixteen percent of RMDL and 23% of PWCL holders were female. Six per cent of female RMDL holders were the registrants of a boat and 6% of female PWCL holders were registrants of a PWC. In the case of male licensees these same figures for registrants were 26% and 16% respectively.

The median age of female holders of an RMDL was 47 years for those who were the registrant of a boat and 42 years for those who were not. The median age of male holders of an RMDL was 50 years in both cases.

The median age of both male and female holders of a PWCL was 42 years for those who were the registrant of a PWC and 36 years for those who were not.

These key finding have been primarily drawn from the data in the four tables which accompany this bulletin.
