## Recreational marine licence census June 2014

## **About this publication**

This publication presents the results of a census taken of the number of current Queensland recreational marine licences on 30 June 2014. The data presented in this publication was extracted from the Department of Transport and Main Roads TRAILS Registration System (the register) on 8 July 2014.

In Queensland, being issued a *Recreational Marine Driver Licence* (RMDL) is a necessary prerequisite to being issued with a *Personal Watercraft Licence* (PWCL). Both of these marine licences are issued in perpetuity and so will remain current unless they are surrendered or cancelled, or until the effluxion of time assures the licence can no longer be in use.

The graphs and tables provide the number of current recreational marine licences classified by type, maritime region, the age and gender of the licensees, the year in which a licence was issued and whether or not a licensee was the registrant of a personal water craft (PWC) or boat (a vessel that is not a PWC).

## **Key Points**

At 30 June 2014 records indicate that 789,643 people held a current marine license; one license for every five people over 15 years of age resident in Queensland.

RMDL were held by 789,280 people of whom 127,810 also held a PWCL. The remaining 363 people are holders of an interstate recreational boat licences or a commercial marine qualification, to whom a standalone PWCL has been issued.

Twenty-two per cent (175,481) of the 789,280 holders of an RMDL have registered at least one of 199,903 recreational boats. Thirteen per cent (16,919) of the 128,173 holders of a PWCL have registered at least one of 18,524 PWC. Only 3080 licensees have registered at least one of 4736 boats and at least one of 4339 PWC. The majority (2746) of these licensees have registered one boat and one PWC.

Licensees residing within the Brisbane Maritime Region hold the majority of RMDL (63%) and PWCL (77%). Nineteen per cent of those who hold an RMDL and 13% of those who hold a PWCL have a registered vessel.

In the Mackay Maritime Region, which accommodates only 6% of RMDL holders and 4% of PWCL holders, licensees are more likely to have registered a boat (31%) or a PWC (14%) than those in any other maritime region.

Women hold 16% of RMDL and 23% PWCL and are less likely to have registered a boat (6% vs. 25 %) or a PWC (6% vs. 15%) than male licensees.


The average age of the holder of an RMDL who has a registered boat is 51 years while the average age of those who do not have a registered boat is 50 years. The average age of the holder of a PWCL who does have a registered PWC is 43 years while the average age of those who do not have a registered PWC is 38 years.

Eleven per cent of current RMDL were issued between 1962 and 1980. A further 11% were issued between 2010 and 2014. In both of these cases 22% of the licensees have registered a recreational boat.

Twenty-nine per cent of current PWCL were issued in 2005; the first year in which PWCL were issued. A further 44% were issued between 2010 and 2014. In the first of these cases 10% of licensees have registered a recreational PWC while in the second 15% of licensees have registered a recreational PWC.



Graph 1: RMDL and Boat Registration






