DRAFT RESPONSE

Statement from Mark Bailey, Minister for Transport and Main Roads

As I have previously outlined, while the correct figure for the thirty-five year contract to return train manufacturing to Queensland was posted online on the day of the media conference in Maryborough, an error was made and the \$9.5 billion figure should have been included in that day's media release after the signing of the final contract following the close of business the day before.

I acknowledged responsibility for this error early last week, staff were counselled and both the Premier and I have apologised for the error.

Background

TMR provided a draft media release regarding the QTMP project to my media team on 19 June. The draft media release contained the full estimated cost of the project, \$9.5 billion.

The \$9.5 billion figure was removed from the press release and no other figure was added in its place as the final contract had not yet been signed. I approved this draft version for further input and it provided to the Premier's office.

The \$9.5 billion figure was uploaded to the TMR website on the day of the Maryborough media conference on 30 June.

Can talk biggest investment in rollingstock.

• The program will bring train manufacturing back to Queensland, supporting more than 1300 jobs over the term of the contract.

To date we have referred to 800 jobs in Maryborough. Consistency is good. We can add other jobs when we are getting going on Ormeau, for example. People will understandably think of these two things separately.





The \$9.5 billion program budget will be largely reinvested directly back into Queensland, with Downer making guarantees for the extensive use of local suppliers.




